Written Comments Received:

JC Garbutt

I would like to reiterate my strong support for funding an arborist and for the Haw River State Trail in our upcoming budget. I've written to you before about the great value that this support will bring to our County but I simply want to keep beating this drum! We really are at that time in our County when we need to make sure we are doing all we can to protect our natural resources for all our citizens as we experience exceptional growth. We won't have many options left in 5-10 years.

In Person:

Good afternoon, Commissioners. My name is Missy Johnson. I am the senior director of resident experience at Galloway Ridge; a nonprofit continuing care retirement community located just down the street from here. This June marks a very special milestone for our community. It is our 20th anniversary. We serve over 450 seniors in Chatham County, and we have over 350 employees at Galloway Ridge. Since opening our doors in 2,005, Galloway Ridge has been proud to serve older adults in Chatham County, providing a full continuum of care alongside a vibrant and aged lifestyle. We are also home to the Duke Center for Living, which plays a key role in promoting wellness for our residents and our broader community to celebrate this milestone. We'll be hosting a 20th anniversary toast in celebration. Have to have champagne on Thursday, June 26th from 4:00pm to 5:30pm on our campus and we would be honored to have you. Our county commissioners join us as our guests. I believe several of you have already Rsvp. But we would love to invite each one of you. This celebration will bring together our residents, our staff, and our community partners, to reflect on the two decades of service growth and our local connection. In addition, we would be grateful if you would consider issuing a proclamation or recognition in honor of this occasion. We would be happy to provide any background or supporting information to assist with that process. Thank you again for this opportunity to speak, and for your continued support of communities like ours that are dedicated to enriching the lives of older adults in Chatham County. Thank you.

Bill Arthur

Hello, my name is Bill Arthur. I'm a Chatham County resident. I see that you'll shortly be meeting with your lawyers to discuss the handling or settlement of the Summit church case. Let me urge you not to settle in a way that allows this Megachurch to

establish itself on 15-501 just north of here. The additional traffic and the added safety concern it will bring will affect the quality of life, and even the safety of Chatham residents, and you are justified in declining the Church's rezoning request. The Church contends that your denial of this request places a substantial burden on the Church. Not so. This burden is a self-inflicted burden by the Church. It already has 13 sites in the triangle region. It wants to add another one to work towards its goal of a church within 15 min of any of its congregants, and it also has a goal of a thousand sites. By 2050 they have set up a problem of their own making and expect the rest of us to solve it. But no one is stopping them from practicing their religion. No one is shutting down their sanctuaries, and if they really want to come to Chatham County, there is land elsewhere that could serve their purposes. To deny the rezoning, in fact, leaves the situation at status quo. Now the Church is trying to play the religious discrimination charge that the county is violating the religious land use and institutionalized Persons Act passed by Congress in 2000. This is disingenuous. In fact, the law may well be unconstitutional. The International Municipal Lawyers Association, the National League of Cities and the American Planning Association have so contended, and an amicus brief. In the case of Cutter V. Wilkinson, religious belief and religious speech are protected, but religious conduct, because it can harm others, and the public good may be regulated, and case law has shown that religion doesn't always prevail in such cases as the amicus brief, says. The need for sensible land use and zoning laws as applied to religious projects, has increased over time as the traditional concept of a small church serving the immediately neighboring community has been supplanted by modern churches, not dependent upon local residents as its communicants, and in some instances attracting people from far distances, as would be the case with the Summit Church with the land-use provisions of RLUIPA, as it's called. Congress has attempted to take over one of the most clearly recognized arenas of local and State control. But Congress is not equipped to determine how many parking spaces are needed for each seat in a church, or what flow of traffic is appropriate in a residential neighborhood, or what levels of occupancy are appropriate in a particular district. To boil it down. RLUIPA is unconstitutional because it takes over land, use law, and creates 2 classes of citizens, religious landowners who can avoid the application of general neutral land, use laws and all other landowners. It is fundamentally unfair beyond Congress's power, and violates the separation of Church and State, wrote Marcy Hamilton, a lawyer who successfully won a case in the Supreme Court that declared the Religious Freedom and Recovery Act, unconstitutional as it applies to the States. I hope you will keep this in mind when you talk with the lawyers. Thank you.

Health Director Mike Zelek and Social Services Jennie Kristiansen presented the annual Community Child Protection Team and Child Fatality Prevention Team Reports.

They reviewed the goals of the team and the members. They reviewed the recent legislative changes and actions. They gave an overview of the child welfare case review goals and findings, along with the recommendations for improving. They reviewed the child fatalities, the 2024 successes, and the 2025 opportunities.

Receive presentation on the Chatham County Low Income Tax Relief Program and vote for proposed changes

Housing and Community Development Director Jason Smith presented the Chatham County Low Income Tax Relief Program.

Smith stated that \$200,000 was allocated to help support low-income Chatham County families by offering up to \$500 to qualifying applicants. Applicants must reside in their home for 5 years or more, a family's total income must be below 60% of the current AMI, not receiving any other tax exclusion or exception, and the applicant must be current on all property taxes.

Smith stated as of June 9, 2025, eight-four applications were received, seventy-six were approved, which is about ninety percent. A total of \$34,159 was paid directly to applicant families.

Smith stated that 50% of the denied applicants were already receiving another tax incentive. Applications have slowed considerably over the past month showing signs of program saturation. The program requirement changes appear necessary to allow for these funds to be dispersed to the residents most in need.

Smith shared recommended changes to the Area Median Income (AMI) being adjusted from 60% to 80%, which would allow residents to apply for the low-income tax relief program even if they are already receiving another tax exclusion or exception.

The Board of Commissioners discussed the adjustment in the Area Median Income and thanked Smith for the update and recommendation.

Chair Howard called for a motion to approve the proposed changes.

Policy Analyst Brenton Hart presented the draft Chatham County Advisory Committee Policy along with a list of differences between the current policy and the proposed policy.

Hart reviewed the background of the policy rewrite. Hart stated that staff identified several areas during further drafting where additional clarification and guidance may be needed from the Board of Commissioners.

Hart shared the major themes in the rewrite including committee formation and dissolution standards, general membership standards, strengthened appointment procedures and administration, defined committee and staff roles, voting and meeting rule clarifications, defined public access requirements, developed ethics and conduct framework, oversight and accountability administrative requirements, and additional applicability of sections to other boards.

Hart reviewed each of the major themes and asked clarifying questions of the Board of Commissioners around all applicants and those asking to be reappointed completing an application, deadlines for commissioner recommended seats, quorum requirements. The Board of Commissioners discussed the policy updates and agreed with the proposed changes.

My name is Steve Ganley, and I'm a resident of Bear Creek. I'd like to ask the board members a question. Please raise your hand if the answer is yes. Which of you have fully reviewed the training materials associated with the DEI program. Thank you. I have reviewed a lot of the DEI program material and found some disturbing information being distributed within the Chatham County workforce and I'm not sure that the Chatham County residents know the actual contents of this DEI material or if they are even aware of the program exists. Probably the most important takeaway from the material is the constant references to groups, categories, classes that people fall under. People are identified as belonging to a certain race, gender, sexual orientation, culture, etc rather than each one being a unique and autonomous creature of God. An example of one such group is the privileged group. The material states if you are white, male, cisgender, heterosexual, able-bodied, of higher class, socioeconomic or education level, you are privileged. These privileges are interconnected and often overlapped. I counted examples of micro aggressions in the DEI sections 1, 2, and 3 plus a couple of other documents and found the following. References to those who were victims of micro aggressions included black, Indian, women, Muslim, Hispanic, LGBTQ+, POC, and BIPOC. A total of 23 victims. Then there's proper workplace speech. Words like he, she, ladies, gentlemen, should be replaced with more inclusive words, such as they, them, theirs, or asking a person what their preferred pronoun is. Grandfathered, replaced with legacy, exempted, excused, preapproved. Homosexual, with gay, lesbian, bisexual, transgender, or queer. Why is this even being discussed in the workplace at all? Finally, the material suggests that the police are targeting a certain group of people unjustly. I know our police and they only target one group of people and those are criminals. This program is nothing more than social engineering and it has no place anywhere in government. Chatham County taxpayers want the most qualified, hardworking, customer oriented professionals available. We do not care what gender, sexual orientation, race, etc the employee may be. This DEI program does exactly the opposite. Its purpose is to have a workforce made up of identifiable personal characteristics instead of merit. Please cancel DEI funding immediately. Your decision will determine whether or not I need to

pursue the issue further. Thank you.

Esteemed commissioners and listeners. I don't think I've ever been here requesting or demanding anything ever, so good evening. This concerns the property tax relief program. I found myself in a situation where I felt like an aspect of it was unfair. I don't feel punished exactly, but I feel I feel penalized. I sold a property in Chatham County and then I bought another property, and I closed on that property on February 3rd and I began occupying the home on this property on March 8th. I found myself all of a sudden ineligible for property tax relief, because I did not meet the occupancy deadline of January 1st. My request is that this January 1st deadline as one of the preconditions be reviewed and that it be modified and extended to have a larger range than just one day, January 1st. Wouldn't it be more significant and telling to know that I have been a citizen of Chatham County and a taxpayer in Chatham County, going back to 2005. My record of tax payments is impeccable. It's perfect. I have always paid my taxes without default, without ever going into arrears. I absolutely understand the other conditions. You know I can't earn more than \$36,000 a year. I have to own my own house. I have to be at least 65 years old. And but it's this one condition of holding me to January 1st which I find to be a little bit unfair. I would request that something like having a range of when I can. When a new homeowner could occupy a house that the range be extended to, for example, to April 1st. That full time occupancy would be happening no later than April 1st. If I had closed on my house January 2nd, I would be ineligible for tax relief and I find that just a little bit unfair.
