Resolution of the Chatham County Board of Commissioners

FOR THE ADDITION OF STREETS OR ROADS TO THE NORTH CAROLINA SYSTEM OF SECONDARY ROADS

BRIAR CHAPEL SUBDIVISION

- **WHEREAS**, Chatham County wishes to cooperate in any way possible with the North Carolina Department of Transportation, Division of Highways, to place streets and roads within the County on the North Carolina System of Secondary Roads, operated and maintained by the North Carolina Department of Transportation; and
- **WHEREAS**, Briar Chapel Parkway from the centerline intersection of US 15-501 to the centerline intersection of Serenity Hill Circle N and Wildwind Drive , 18,025 ft.; and
 - WHEREAS, Great Ridge Parkway from STA 11+00S to STA 21+75.15N, 7.590 ft.; and
- **WHEREAS**, Bennett Ridge from the centerline intersection of Bennett Mountain Trace to the centerline intersection of Dark Forrest Drive, 835 ft.; and
- **WHEREAS**, Bennett Mountain Trace from the centerline intersection of Briar Chapel Parkway to the centerline intersection of Great Ridge Parkway, 1,415 ft.; and
- **WHEREAS**, Saxapahaw Way from the centerline intersection of Briar Chapel Parkway to the centerline intersection of Great Ridge Parkway, 1,000 ft.; and
- **WHEREAS**, Dark Forrest Drive from the centerline intersection of Briar Chapel Parkway to the centerline intersection of Bennett Mountain Trace, 1,355 ft.; and
- **WHEREAS**, Hill Creek Blvd. from the centerline intersection of Great Ridge Parkway to the centerline intersection of Serenity Hill Circle S, 1,935 ft.; and
- **WHEREAS**, Harlow Bend from the centerline intersection of Hill Creek Blvd. to the centerline intersection of Tabardy Mill Port, 800 ft.; and
- **WHEREAS**, Tabardy Mill Port from the centerline intersection of Great Ridge Parkway to the centerline intersection of Hill Creek Blvd., 645 ft.; and
- **WHEREAS**, Fallenwood Lane from the centerline intersection of Great Ridge Parkway to the centerline intersection of Hill Creek Blvd., 600 ft.; and
- **WHEREAS**, Tobacco Farm Lane from the centerline intersection of Briar Chapel Parkway to the centerline intersection of Fallenwood Lane, 700 ft.; and
- **WHEREAS**, Kimbolton Place from the centerline intersection of Hill Creek Blvd. to the centerline intersection of Tobacco Farm Way, 515 ft.; and
- **WHEREAS**, Owens Town Road from the centerline intersection of Polkberry Bend Drive to the centerline intersection of Summersweet Lane, 830 ft.; and

WHEREAS, Polkberry Bend from the centerline intersection of Serenity Hill Circle N to the centerline intersection of Tobacco Farm Way, 690 ft.; and

WHEREAS, Tobacco Farm Way from the centerline intersection of Serenity Hill Circle N to the centerline intersection of Briar Chapel Parkway, 1,535 ft.; and

WHEREAS, Serenity Hill Circle N from the centerline intersection of Briar Chapel Parkway to the centerline intersection of Briar Chapel Parkway, 3,345 ft.; and

WHEREAS, Harlow Bend from the centerline intersection of Tabardy Mill Port to the centerline intersection of Hill Creek Blvd., 800 ft.; and

WHEREAS, Summersweet Lane from the centerline intersection of Serenity Hill Circle N to the centerline intersection of Owen Town Road, 690 ft.; and

WHEREAS, Serenity Hill Circle S from the centerline intersection of Briar Chapel Parkway to the centerline of the Cul-de-sac, 1,615 ft.; and

WHEREAS, Grovewood Lane from the centerline intersection of Great Ridge Parkway to the centerline intersection of Tobacco Farm Way, 830 ft.; and

WHEREAS, Endoor Drive from the centerline intersection of Grovewood Lane to the centerline intersection of Great Ridge Parkway, 450 ft.; and

WHEREAS, Turtle Point Bend from the centerline intersection of Great Ridge Parkway to the centerline intersection of Great Ridge Parkway, 420 ft.; and

NOW, THEREFORE, BE IT RESOLVED, that the Chatham County Board of Commissioners request that subject streets, Briar Chapel Parkway, Great Ridge Parkway, Bennett Ridge, Bennett Mountain Trace, Saxapahaw Way, Dark Forrest Drive, Hill Creek Blvd., Harlow Bend, Tabardy Mill Port, Fallenwood Lane, Tobacco Farm Way, Kimbolton Place, Owen Town Road, Polkberry Bend, Serenity Hill Circle N, Summersweet Lane, Serenity Hill Circle S, Grovewood Lane, Endoor Drive, and Turtle Point Bend be added to the North Carolina System of Secondary Roads upon meeting all criteria as established by the Department of Transportation.
