OVERVIEW OF SECOND BLOOM


Established in 2017 following the closure of FVRC.


To present the current status, achievements, and future goals of Second Bloom for providing emergency shelter to survivors in Chatham and secure county support for these strategies.




NEED FOR EMERGENCY SHELTER

- Reliance on motel/hotel rooms is unsustainable and expensive (See Appendix B of report)
- Chatham has a high need for stable and suitable emergency housing options: 47% of renters here have difficulty affording their home
- SBC consultants and staff are researching best practices for sheltering and housing survivors, with input from survivors, advocates, and community stakeholders
- Flexible emergency housing options are critical as the area expands its growth



FUNDING CRISIS


VOCA Funding in North Carolina

\$17,944,516 or 42% Cut


PROPOSED HOUSING SOLUTIONS

Short-Term Solutions:

- Secure diverse rental options: SBC currently has two emergency housing sites with a total of 5 bedrooms available
- Semi-permanent options are being explored further with new transitional housing grant
- New funding secured and additional grants applied for (\$1.5M total requested in potential support, \$550K has been secured for transitional housing)

Longer-Term Solutions:

- Multiple, diverse units and potential capital campaign for new shelter facility
- Partnership with developers for building and land donations or renovations
- Corporate partnership development


Our revenue increased from \$180,000 to \$372,760 in 2022.



Have conducted five site visits (3 in NC, 2 in VA), with four more planned in early 2025.


OBSERVATIONS/TRENDS

- Trauma-Informed Design
- Non-Confidential Location
- Families and survivors have private rooms
- No rules, just guidelines
- No restrictions based on age or gender
- Off-site options for folks of different genders as a best practice
- Partnership with local animal rescue

NEXT STEPS

Three more in-person site visits in NC, January 2025. Will incorporate those findings into our plan.

FOCUS GROUP SUMMARY




THEMES



- Two community focus groups, 19 participants
- One in English (Pittsboro)
- One in Spanish (Siler City)
- Community Survey will be dispersed in December (for survivors)
- Latinx community is largely unaware of Second Bloom's services and wants to see SBC center trauma-informed care for undocumented immigrants. Support groups have been a lifeline for Latinx survivors there.
- Importance of financial literacy, assistance finding employment, technology safety planning, emotional support in group and one-on-one, and educating religious communities.

SUMMARY

The recommendation of the Shelter Advisory Board (SAB) for providing emergency shelter options to survivors in Chatham is to pursue multiple options of seamless access to care, to include emergency, semipermanent, and more fluid options.

The SAB, which leverages the expertise of local and seasoned advocates, will continue to make decisions on how potential models will best function in our community. These decisions will be presented to the community by the SBC Board of Directors according to the recommendations of the SAB, with input from survivors and advocates.

A combination of short-term/emergency and long-term solutions is necessary, and the support of the county is critical to our success.
