<u>19-2919</u> Chatham County Schools Presentation

Budget Director Lisa West had a followup about the SNAP program. She will work with DSS Director Jennie Kristiansen to get the information the commissioners requested.

Chatham County Schools Superintendent Dr. Derrick Jordan gave a presentation to the Board. (Presentation attached) The Schools Senior Leadership Team was also present.

Ms. West asked if there is a financial impact if schools fall below the grade D. Dr. Jordan said there are three schools in the district that have been graded as low performing and two of those schools have risen above that grade. More money is funded into those low performing schools.

Commissioner Howard stated the State School Board Association has the calendar as a legislative goal as well as NCACC. Dr. Jordan said the Superintendent Association does as well.

The schools are launching www.Teachforchathamnc.org to help recruit and retain teachers.

The schools have been able to maintain tuition reimbursement for teachers.

Vice Chair Hales asked if the schools are considering providing free breakfst for all children. Dr. Jordan stated they looked to Rockingham County who had a tremdous hole to fill. It is free but not really free. The federal government covers some of the cost but not all.

Chatham County Schools Finance Officer Tony Messer said the state is asking the schools to budget a 5% increase in health insurance.

Commissioner Howard asked about Chatham Grove Elementary. Dr. Jordan said it is built at a capacity of 750 students and is based on known factors.

Vice Chair Hales asked what is coverered under enhancements. Dr. Jordan stated the arts, music, pysical education, everything but core subjects.

Commissioner Crawford asked when the Board can have a tour of the school sites. Dr. Jordan said there is a part of the webpage devoted to the two new schools.
