

COVID State and County Trends (as of 11/12/20)


North Carolina

- 303,454 people have tested positive for COVID
- 4,706 people have died of COVID
- Positivity Rate = 7.9%
- Rolling 7 day average has increased



Chatham County

- 2,123 people have tested positive for COVID
- 63 people have died of COVID
- Positivity Rate = 5.6%
- Rolling 7 day average has increased



Key Points

- Cases on the rise
- Concern with colder weather and holidays ahead
- Updated Executive Order limits indoor gatherings to 10 people or less
- Guidance for the holidays
 - Best to stay within household
 - Limit gathering size
 - Practice 3 Ws
 - Get tested (see chathamnc.org/coronavirustesting for options)
 - Stay away from others if you have even mild symptoms

Public Health Response Updates

- Weekly drive-thru testing at Northwood (Thursdays) and Chatham Central (Mondays)
- COVID vaccine planning ongoing
 - Don't have an exact timeline but trials showing some promise
 - Focus on equitable distribution following state vaccine plan
- Continue to respond daily to cases
 - Back online with case investigations 2 days after cyber incident began
- Ongoing regular meetings with key stakeholders/EM, long-term care, businesses, childcare, schools, vaccine planning team and others

Internal Coronavirus Relief Fund Use

- Public Health & Medical Expenses (\$175,000):
 - Conducting departmental check-ins to make sure everyone has what they need to re-open when we decide it is safe to do so
 - Purchasing items in conjunction with Emergency Management and Facilities
 - Purchasing Chatham County logo masks for employees
- Payroll Expenses (\$1,285,221.12):
 - Identified key staff salaries that will be covered by CRF
- Compliance Expenses (\$300,000):
 - Distributed items to requested via the needs assessment to address teleworking needs
 - Purchasing Zoom packages to support virtual meetings
- Exploring other projects to determine how we can safely support the Chatham community

External Coronavirus Relief Fund Use

- Nonprofits (\$200,000):
 - Finished Round 1 and Round 2 of the Nonprofit Application Processes
 - All nonprofits submitted their first and second reports to the County
 - Reimbursements should be issued soon
- Municipalities (\$726,740):
 - All municipalities have received and spent their allocations
 - They are working on submitting final reports to the County
- Economic Support (\$195,000):
 - Exploring options with EDC
 - Continue working with agencies to streamline emergency supports for individuals impacted by COVID-19
- Exploring other ideas to support the greater Chatham community
