## To Whom It May Concern:

I am writing to express my interest in serving on the Chatham County Board of Health as a community member. I am a licensed clinical social worker and in addition to my work as a trauma-therapist in private practice, I am also the founder of EJ Wellness Consulting, a group practice that is committed to offering therapeutic services to clients who come from traditionally marginalized communities.

Since moving from New York City to North Carolina in the summer of 2022, I have been looking for opportunities to connect to the larger local community and participate in activities that enhance the wellbeing of others. In the last two years, I have engaged in and supported local activism and outreach, including participating in county commissioner meetings and working with neighbors on local community issues.

As a social worker, I am aware of the impact larger societal systems impact individual lives and how policies can help or harm communities. Prior to starting my own practice, I was the Senior Clinical Director of Anti-Trafficking Program, Community Programs and Hotlines at Safe Horizon, the nation's largest crime victims' services provider. Survivors of interpersonal crime and abuse often experience a multitude of barriers on their journey toward a safe, healthy and fulfilling life due to lack of access to resources whether it's mental health services, medical treatment, safe and affordable housing and childcare to name a few. In my professional roles, I have collaborated with city council members, law enforcement, policy makers and stakeholders to advocate for the needs of survivors. I have served on committees that were successful in developing streamlined connection to trauma-informed health services for women, expanding access for LGBTQ survivors in our domestic violence shelters and use of technology to broaden our reach to young survivors and advocating for the change in the emergency housing application process through the New York City Housing Authority. My work also included ensuring the care for our clients through regular collaboration with medical professionals, child protective services, the police and family or criminal courts. The programs at Safe Horizon support a diverse group of clients from different geographic, racial, cultural and socio-economic backgrounds and understanding how interventions are understood and interpreted based on clients' cultural norms have been integral to the success of the programs. In addition to my work at Safe Horizon, I was also an adjunct associate professor at New York University's Silver School of Social Work where I have taught courses on systemic oppression, trauma and interpersonal violence, and delivering services to vulnerable families at the masters and bachelors levels. I have provided training to schools, non-profit and for-profit organizations on mental health, trauma and anti-oppressive practices in the workplace. I have also spoken on these topics at national conferences and panels.

The core values of service, social justice, dignity and worth of the person, importance of human relationships, integrity and competence that are the foundation of the social work code of ethics guide the work I do. I believe my professional background and education would serve me well as a member of the Board of Health.
