

AHAC Goals


- 1. Increase the number & diversity of affordable rental options.

- 7. Improve economic mobility.






2022 Data Update: Affordable Rental Units Needed




Rental Need & Affordable Supply 2019-2022




Total Voucher Amounts By Type



Data Update Highlights for 2022

- Number of affordable housing units decreased by 126 units- largely due to decreasing NOAH (lost 84) and total available Housing Vouchers (lost 42).
- Need for landlord engagement to support utilization of housing voucher assistance
- Local emergency assistance funds have remained constant while available state and federal funds for rental, mortgage, and energy assistance for low-income households decreased "post-pandemic."
- Need for data to better understand unsheltered homelessness in Chatham County
- Need for increased preservation of NOAH, including manufactured home parks

Looking Ahead...

This Coming Year

- In process of allocating \$300,000 in Housing Trust Fund dollars.
- Implement a process to invest Article 46 Sales Tax revenue to achieve short-and long-term housing goals.
- Continue engagement in the UDO development process
- Continue exploring opportunities for manufactured housing preservation, including cooperative ownership models
- Coordinate with the Homelessness and Housing Instability Workgroup to build stronger collaborative processes
