

# Climate Pollution Reduction Grant Regional Climate Action Planning

- Four-year planning grant covering Raleigh-Cary and Durham-Chapel Hill MSAs
- Developed Regional Greenhouse Gas (GHG) Inventory
- Goal: Build a coordinated, data-driven climate plan for local implementation



Why Center Community Organizations in Climate Action Planning

- Climate risks affect every part and everyone in our region and—but not equally
- Public agencies, businesses, and residents must all act together
- Community-based organizations (CBOs)
   bridge the gap between plans and people
- CBOs ensure diverse voices have a role in shaping climate solutions that truly address day-to-day challenges.





## Empowering Local Climate Conversations


The CPRG Community-Based Organization Toolkit equips local organizations to lead conversations about climate change in the region and to discuss climate goals, identify priority climate actions for the organization and the communities they work with, and build support for climate action.

The toolkit helped CBOs to design and facilitate one-to two-hour events that educate, inform, and empower participants to engage in climate action.


## **Engagement Planning and Facilitator Guide**



The Meeting-To-Go toolkit provides materials to support our Central Pines CPRG partners to facilitate a structured dialogue with members of their community around their mission, goals, and tactics that align with development of a Priority Climate Action Plan and Comprehensive Climate Action Plan for the region.

These touchpoints helped CPRC achieve the following for our regional plans:

- Create a shared understanding of climate conditions, risks, and opportunities
- Prioritize equitable engagement and underserved communities
- Identify implementable climate and community solutions
- Build lasting collaborative regional climate action capacity





### **CBO Mini-Grants**

Launched to empower Community-Based Organizations (CBOs) to conduct tailored outreach on climate action, with a simplified application process ensured easy participation and broad engagement.

#### **What the Grants Supported**

- Community workshops & gatherings
- Integration of climate topics into existing events
- Culturally relevant outreach aligned with community needs

#### <u>Impact</u>

2,000+ residents reached
Outreach addressed regional CCAP priorities

#### **Outcome**

Strengthened community capacity to advance **regional climate goals** through **grassroots engagement**.

\$140,000 awarded
25 outreach efforts funded
14 participating CBOs (some with
multiple grants)
