County Manager, Dan LaMontagne, gave a presentation to the Board. (Presentation attached)

Chair Howard asked if the eight million dollars available was the total for all applications or whomever applied first. Mr. LaMontagne said there are multiple

applications and there was hope for a second round of grant funding. The highest scoring applicant will be awarded. The Department of Information Technology anticipated an additional round of funding. That was what the County hoped for. There are more opportunities to get broadband throughout the County. If the County does not reach its goals with G.R.E.A.T. grant funds there was also the Completing Access to Broadband (CAB) program. The Infrastructure and Jobs Act will also provide a funding opportunity to serve more people.

Chair Howard asked if guidance had been released. Mr. LaMontagne said the internet service providers would work directly with the Department of Information Technology.

Commissioner Logan asked the total residents or percentage of residents served in the county. Mr. LaMontagne said there had been some difficulty with maps. The County used the NC One state maps that are based on data sent in by internet providers. I will discuss more of this point later in the presentation.

Commissioner Dasher asked whether providers would connect to existing fiber in front of residents' homes. He had heard in the past providers would refuse to connect. Mr. LaMontagne spoke to providers about this issue. He understood that some existing fiber may not be setup for residential connections, but this program could provide a great opportunity to connect. He hoped for the refining of broadband connection maps.

Vice Chair Gomez Flores asked if there were multiple applicants. Mr. LaMontagne said the county would not select anyone but would try and partner with all applicants to ensure their applications are strong with the State.

The State would likely select an overall winner, and the county would provide a match with whomever was chosen.

Subdivision Administrator Kim Tyson reviewed the specifics of the request.

Commissioner Hales asked if the cemetery was land locked. Ms. Tyson said she thought the Holt cemetery was just shy of being on the property.

Nick Robinson spoke on behalf of the applicant. This was by right subdivision and no rezoning needed. Mr. Robinson requested the BOC approve the first plat at the recommendation of staff and the planning board.

Mark Ashness continued on behalf of the applicant. The majority of the project will be age targeted.

Peyton Holland objected to the subdivision.

David Kuzdrall objected to the subdivision.

Scott Smith objected to the subdivision.

Commissioner Hales asked if air strip was public. Mr. Smith said it was private but offered for friends and family. The town homes were directly underneath the approach of the airstrip. He had berms on his gun range.

Robin Anders objected to the subdivision.

Commissioner Logan asked what type of fencing was proposed for the side of the development next to the gun range. Mr. Ashness said pines, solid decorative fencing, and berming.

Commissioner Dasher asked if town homes were part of phase 1. Mr. Ashness said yes. Commissioner Dasher asked if there was an option to change the age restrictive nature of the development. Planning Director, Jason Sullivan, said that would not have to come back to the board but they would have to pay the impact fees for those 1,000 units. Commissioner Dasher asked what the North Carolina Department of Transportation had requested.

Traffic Engineer, Josh Ranke said dual ingress and dual egress with likely a median. He said dual left turn lanes into the site and a right turn lane. North Carolina Department of Transportation said once a threshold was hit, they could require a traffic light at the entrance. North Carolina Department of Transportation would monitor the traffic to make that determination.

Mr. Robinson said the emergency access road had already been approved by the Fire Marshall and Emergency Operations. It was gated and Emergency Management would have their own ability to access it.

Vice Chair Gomez Flores asked how close Emergency Management Services was. Mr. Ashness said the client owned land on Old US Highway 1 and they have been in discussions with the fire department but it was too early to make a determination.

Commissioner Hales asked if it would be a New Hill address. Mr. Smith said all addresses out there are New Hill.

Commissioner Dasher said there was a lot of bicycle traffic, especially this time of year.

Chair Howard said there were appropriate times and places for subdivisions like this, but this was not it.

CLERK'S REPORT

MANAGER'S REPORT

Dan LaMontagne said the staff was proud of Ms. Ray and her achievement of Master Clerk certification. There are less than twenty-five in the state of North Carolina. There will be some upcoming meetings with updates on the Cary Land Use Plan and other topics.

COMMISSIONERS' REPORTS

Commissioner Dasher had nothing to report.

Vice Chair Gomez Flores received a call from a contractor wanting to get a building permit and there was a four week turn around. He thinks residents should have priority in the permitting department and wanted to see a fee schedule in comparison to other counties.

Commissioner Hales had nothing to report.

Commissioner Logan said the Northwood Lady Cougars Basketball brought home the 3A State Championship. Northwood booster was accepting money to get the team rings. He received a letter from Ashley Palmer, the mother of a student at JS Waters who was subjected to a racist act. The Board of Education is taking steps to address this matter. Commissioner Hales was in attendance at the Board of Education meeting last Monday. The meeting was packed, and it was very moving. Chair Howard was very proud of the community's response. Dr. Jackson is the man for this moment.
