Western Intake Partnership

The Western Intake Partnership (WIP) is focused on securing a long-term regional water supply for the communities they serve. The partnership has been formed by the City of Durham, Chatham County, Orange Water and Sewer Authority (OWASA), and the Town of Pittsboro. Together, the Partnership is moving forward to design and construct water supply facilities and infrastructure to withdraw, treat, and deliver water from Jordan Lake to the Triangle Region communities they serve.

Jordan Lake

Jordan Lake is a vital regional resource. It is a popular place for recreation, supplies water to surrounding communities, controls flooding and water quality, and helps conserve fish and wildlife habitats. Now, the lake will provide the growing communities of the Western Intake Partnership with a reliable source of clean drinking water, while protecting the reservoir's other uses.

To accomplish this, WIP Partners will plan and oversee construction of drinking water distribution and treatment facilities for WIP communities. The project includes:

- A new water intake north of the Vista Point recreation area on the west side of Jordan Lake, with tunnel, pipeline and pump station to deliver water to a new water treatment facility.
- A water treatment facility on property near Jordan Lake.
- Drinking water transmission pipelines to deliver treated water to Partner distribution systems.

During the preliminary phase, the Partnership has investigated facility location and pipeline route alternatives, determined the capacities required, evaluated treatment process alternatives, selected the governance model for the Partnership, and conducted environmental and cultural review investigations supporting the required regulatory processes and USACE outgrant applications.

PDB Delivery Project Phasing

The project is planned to proceed in phases, with the goal of operational facilities by 2031.



WIP Jordan Lake Water Supply Projects

Durham and Chatham County will have capacity shares in the initial facilities; OWASA and Pittsboro are deferring their acquisition of capacity shares in facilities to a later expansion phase. In the future, the treatment facility will be expanded, a transmission pipeline will be built from the water treatment facility to Pittsboro, and a parallel transmission pipeline to Durham will be constructed. OWASA will receive its capacity allocation through interconnects with Durham's water distribution system.

Public Information and Outreach

As the project advances, WIP Partners will hold Open House public meetings (in-person and virtual as appropriate) to share project information, including background information identifying the problem and possible solutions the project will address. Feedback on analysis and decisions made by the WIP team will be sought from key stakeholders to ensure their concerns and aspirations are consistently understood and considered.
