RECITALS

- A. The County and the Contractor entered into an Agreement dated and made effective the 20th day of June, 2006 (the "Agreement").
- B. The County has requested that the Agreement be amended to change the term, compensation, and hours of operation.
- C. The Contractor has agreed to amend the Agreement as requested by the County.

NOW, THEREFORE, in consideration of the mutual covenants and the conditions contained herein, the Parties agree as follows:

- 1. EXTENSION OF TERM. The parties mutually agree to extend the term of the Agreement an additional twelve (12) months, beginning July 1, 2016 and ending at midnight on June 30, 2017.
- 2. HOURS OF OPERATION. The hours of operation shall be as stated on Exhibit A, attached hereto and incorporated herein by reference.
- 3. COMPENSATION and EXPENSES. As compensation for the Services to be provided under this Agreement, the County shall pay the Contractor the total sum as set forth in Exhibit B, attached hereto and incorporated herein by reference. The amounts stated on Exhibit B are all inclusive and include all expenses of every kind and nature, including but not limited to travel, lodging, copying, overhead, outside 'consultants' and other similar and dissimilar expenses and charges.

AGREEMENT TO REMAIN IN FULL FORCE AND EFFECT. Except for the amendments set forth above the Agreement dated June 20, 2006, shall remain in full force and effect.

TRAINING

Training pay for new officers is minimum wage. In addition to any training required by OSHA, each new officer will receive a minimum of 24 hours of on-the-job training with a supervisor and/or trainer, plus a minimum of 4 hours of group training annually to cover site operations, customer service, and/or new information. The County is not billed for training hours.

HOLIDAYS & OVERTIME

The following days are Company Holidays:

- New Year's Day (Collection Centers are closed)
- Memorial Day
- Independence Day (Collection Centers are closed)
- Labor Day
- Thanksgiving Day (Collection Centers are closed)
- Christmas Day (Collection Centers are closed)

Chatham County Collection Centers close at 2:00 pm on Christmas Eve and close all day on Easter Sunday. Holiday pay and overtime pay for the officers is 1.5 times their normal rate of pay; the County is not billed for holidays or overtime, normal rate only. Overtime only applies at the County's request.

EQUIPMENT

Uniforms include: name tag, 4 long sleeve shirts, 4 short sleeve shirts, 4 trousers, summer shorts upon request, light weight and heavy coat, cap, winter and summer hat upon request, belt, badge cap shield.

Personal Protective Equipment (PPE) includes: black steel-toed shoes or boots; leather work gloves; long waterproof and chemical-resistant nitrile rubber gloves; safety glasses.

Lankford Protective Services will also supply each Collection Center with disposable nitrile gloves, disposable aprons, first aid supplies, rain ponchos, and all required paperwork.

A patrol car is provided to the Site Supervisor at no additional cost to the County.
