RE: Closure of a Portion of Moncure Flatwood Road, Chatham County, NC

Dear Mr. Sullivan:

On behalf of Vinfast Manufacturing, LLC, I respectfully request Chatham County, through its Board of Commissioners, close/abandon a portion of Moncure Flatwood Road, as part of a process of creating new access points for the Vinfast manufacturing plant. Attached hereto as Exhibit A is a map depicting the current location of the right of way to be abandoned (the "Old Right of Way"). In consultation with you, we determined that this process of abandonment of the Old Right of Way should be initiated now since it has already been approved by the North Carolina Department of Transportation (NCDOT). A copy of the NCDOT approval of the abandonment is included with this letter.

Pursuant to NCGS§153A-241, Vinfast is requesting that the Board of Commissioners adopt a resolution of intent to close the Old Right of Way and call for a public hearing thereon. A draft resolution to that effect is enclosed. The draft calls for a public hearing to be scheduled on November 21, 2022. Notice of the public hearing must be published and sent to adjoining property owners as well as being posted upon the affected property. Since the Old Right of Way touches only the property that Vinfast already owns and the property of General Shale Brick, Inc., we believe only General Shale Brick, Inc., will need to receive notice. We will send notice to General Shale.

After the public hearing and assuming the Board determines the closure is in the public interest and that no individual is deprived of reasonable access by virtue of the closing, the Board should adopt an ordinance substantially similar to the enclosed draft. A certified copy must be recorded in the Chatham County Registry and will be handled by my office.

I hope that the matter can be placed upon the October 17, 2022 agenda for the Board's consideration. If you or any of the Board members have any questions concerning either the process or the request itself, please let me know.

WHEREAS, Vinfast Manufacturing US, LLC (the "Company") has acquired an approximately 1,750 acre parcel of land, said land being a portion of the Moncure Mega Site (the "Property");

WHEREAS, the Company intends to develop the Property as an advanced manufacturing facility (the "Project");

WHEREAS, a portion of the right of way of Moncure Flatwood Road runs through the Property as shown on the map attached hereto;

WHEREAS, the Company, and the North Carolina Department of Transportation, has determined that the Project will require new access roads to be constructed and dedicated in accordance with the approved plans for the Project;

WHEREAS, the Company has determined that it is in the best interests of the Project to permanently close that portion of Moncure Flatwood Road located on the Property from public access;

WHEREAS, it appears that permanently closing a portion of the previously approved rights of way as more particularly described herein within Chatham County is not contrary to the public interest and that no individual owning property in the vicinity of said street or portion thereof proposed to be closed would thereby be deprived of reasonable access to his or her property;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Chatham as follows:

- 1. That pursuant to NCGS§ 153A-241 it intends to permanently close that portion of Moncure Flatwood Road more particularly described on Exhibit A attached ·hereto and incorporated herein by reference.
