Resolution of the Chatham County Board of Commissioners

FOR THE ROAD MAINTENANCE ADDITION OF SELECT ROADWAYS

BRIAR CHAPEL SUBDIVISION

WHEREAS, Chatham County wishes to cooperate in any way possible with the North Carolina Department of Transportation, Division of Highways, to place streets and roads within the County on the North Carolina System of Secondary Roads, operated and maintained by the North Carolina Department of Transportation; and

WHEREAS, a letter received from the North Carolina Department of Transportation Division 8, District 1 District Supervisor has requested an appropriate resolution for the addition of 31 streets listed on the Briar Chapel Subdivision Additional Streets document in the Briar Chapel Subdivision; and

WHEREAS, a street summary, plats, and maps showing the location of the requested additional streets; and

WHEREAS, the Office of NCDOT Division 8, District 1 has investigated the subject streets and found them to meet minimum requirements for addition; and

NOW, THEREFORE, BE IT RESOLVED, that the Chatham County Board of Commissioners request that subject streets, Briar Chapel Parkway, Great Ridge Parkway, Granite Mill Boulevard, Landover Circle, Highveld Avenue, Mooreland Avenue, Salt Cedar Lane, Old Piedmont Circle, Rock Ledge Drive, Juneberry Drive, Shady Oak Trail, Beacon Ridge Boulevard (frmly. Manor Wood Drive), Beacon Ridge Boulevard, Meadows Ridge Boulevard, Meadows Edge Drive, Quail Place Trail, Wild Indigo Way, Mallard Landing Drive, Tyner Loop Circle, Monarch Trail, Cardinal Ridge Road, Woodland Grove Lane, Great Ridge Parkway, Cooper Lead Avenue, Vandalia Avenue, Chauncey Circle, Boulder Point Drive, Middleton Place, Clifridge Court, Boone Street (frmly. Foxbrook Pl.), Post Oak Road, Whispering Wind Drive, be added to the North Carolina Department of Transportation Division 8, District 1 Road Maintenance responsibilities.
