

# Overview – Broadband





#### **Legal Information**



- Counties are unable to provide high-speed Internet broadband service directly to residents.
- Counties may provide grants to ISPs for the purpose of expanding service in unserved areas. (SL 2012-86)

#### **Unserved Locations**






#### **Unserved Location Funding - RDOF**

**The Rural Digital Opportunity Fund** will provide \$20.4 billion in funding over a ten-year period to support the construction of broadband networks in rural communities across the country.

Eligible areas include those without current (or already funded) access to adequate broadband service, defined as 25 Mbps downstream and 3 Mbps upstream (25/3).

#### **Additional Info:**

- Chatham County RDOF grant is through Charter Communications (Spectrum).
- 6 Year Build Window. (Entering 3<sup>rd</sup> Year of Grant)
- Additional federal funding unable to be used in these areas.
- Estimated Locations to be Served: 3,448




## **Unserved Location Funding – GREAT Grant**

The **Growing Rural Economies with Access to Technology (GREAT) Grant** is a competitive grant program that provides funding to private sector broadband providers to deploy last-mile broadband infrastructure to unserved areas of North Carolina. The original GREAT Grant program was initiated in 2018 and launched in 2019 and subsequently became a recurring state-funded grant program within the NCDIT Broadband Infrastructure Office.


#### **Additional Info:**

- Chatham County has received two GREAT grants. (AT&T and Brightspeed)
- Total Project Cost: \$8.1M
- Total Grant Amount: \$5.9M
- Total Match Amount (State & County): \$2.2M
- County Match: \$519,228.20
- Locations to be served: 2,404



#### **Unserved Location Funding - CAB Grant 1.0**

The **Completing Access to Broadband (CAB) Program** provides an opportunity for individual N.C. counties to partner with NCDIT to fund broadband deployment projects in unserved areas of each county. N.C. Session Law 2021-180 appropriates \$400 million from the American Rescue Plan Act for this new program.




#### **Additional Information:**

- Counties must work with NCDIT to develop projects
- Chatham County Board of Commissioners directed 2.5M to this program. Will now be covered by NCDIT due to State law changes.
- Locations to be served: 2,555

# Digital Inclusion Plan




## What is a Digital Inclusion Plan?

#### Digital inclusion plans assess:

- Tools and resources counties currently have.
- Areas and populations of people who do not currently have access to broadband service (or insufficient, slow connections).
- Resources or strategies needed to fully connect everyone in the region.
- How to make internet-enabled devices more accessible.
- How to increase availability of digital literacy training.
- Availability of technical support.




#### FCC National Broadband Map - Wired



## **Availability**

Availability in the context of digital inclusion refers to <u>broadband</u> <u>infrastructure</u>.

- **Goal 1:** Create better broadband mapping across Chatham County.
- **Goal 2:** Coordinate increased connectivity for unserved areas.
- **Goal 3:** Promote improved connectivity and stability of broadband connections.



Overcoming the digital divide & opening doors to opportunity

Lifeline Discount Program

#### Access

Access refers to the ability for someone to gain <u>access to available broadband</u>. The barriers to access include affordability concerns and lack of access to computing devices.

- **Goal 4:** Increase equitable communications for in-need communities around affordability services.
- Goal 5: Expand access to digital devices.
- **Goal 6:** Increase access to internet connectivity in public spaces.
- Goal 7: Increase hotspot availability.

- **Goal 10:** Establish workforce development programs in broadband-related fields.
- **Goal 11:** Create events celebrating digital inclusion.

#### What is ODEL?

- ✓ NC Department of Information Technology awarded 25% of grant awards
  - \$30M in funding (originally \$14M)
  - American Rescue Plan dollars passed through NCDIT
- ✓ Who could apply?
  - Community services (local governments, local libraries, K-12 school systems), nonprofit organizations, higher education institutions, and regional entities

#### ✓ Eligible Uses:

- •Affordable, reliable high-speed internet
- •Provision of Internet enabled devices (computer, laptops, etc.) that meet users' needs
- •Provide access to digital literacy and skills training
- •Provide quality technical support

✓ Funding Range: \$400,000 per county served, up to \$1.5M total



#### **Structure of the Award**

- ✓ Recipient of funds Central Pines Regional Council
  - Award amount: \$800,000
  - Grant Award Period: September 1, 2024, to December 26, 2026
- ✓ Subrecipients
  - Kramden Institute
  - Chatham County
  - City of Durham
  - UR Restored Ministries
  - Chatham and Durham Literacy Centers
  - Chatham and Durham K-12 School Systems
- ✓ Partners
  - Innovate Chatham
  - Digital Durham



#### **Structure of the Award**

- Purpose: Expand *capacity* to advance digital equity in Chatham and Durham counties, and the entire CPRC region.
  - Digital literacy trainings
  - Access to devices
  - Multijurisdictional/regional coordination
  - Community-Based Organizations
  - Data Collection and Assessment

#### ✓ Populations Served:

- Justice-impacted
- Rural populations
- Seniors (60+)
- Low-income
- Low literacy
- Individuals with a language barrier
- Racial or ethnic groups

#### **Metrics**



- ✓ Quantitative
  - Number of educational opportunities offered to CPRC region (i.e. webinars)
  - Number of devices distributed
  - Participant demographics (age, race/ethnicity, gender)
  - Class impact (percentage of students whose skills improved pre- to post-class).
  - Participant feedback (program, instructor, and computer satisfaction)
  - Additional funding opportunities pursued (geared towards furthering implementation of Chatham and Durham's digital equity plans and related regional projects)
- ✓ Qualitative
  - Storytelling
  - Feedback from clients at community-based organizations
