Chatham Transit Network Executive Director Anna Testermann presented an update on a potential micro transit program.

Testermann stated that the program is a flexible, on-demand public transportation service that bridges the gap between traditional fixed-route buses and private ride-hailing services like Uber and Lyft.

Testermann stated that the proposed pilot programs for the towns would including the Town of Siler City would have two vehicles running Monday through Saturday and the Town of Pittsboro would have one new vehicle running Monday through Saturday, with times to be determined.

Testermann shared the cost estimate and answered questions of the Board of Commissioners.

25-0487 Receive an update on the Chatham County low-income tax program

#### <u>Attachments:</u> Chatham County Low-Income Tax Relief Program

County Manager Bryan Thompson shared an overview of the Chatham County Low-Income Tax Relief program. The Chatham County Low-Income Tax Relief Program is an allocation of \$200,000 to support low income families and individuals in the County that provides up to \$500 of property tax assistance to those residents that qualify based on program guidelines.

Thompson shared the program guidelines:

- 1. Must be a Chatham County North Carolina resident.
- 2. Must have owned and resided in their home for at least 5 years
- 3. This must be primary residence.
- 4. Must be current on all property taxes.
- 5. This program cannot be used if there are unpaid or delinquent property taxes.

Thompson stated if an applicant is approved, assistance will be 50% of the current year tax bill up to a \$500 maximum benefit. The household earned income must be at or under 80% of the Average Median Income for Chatham County.

Thompson shared the steps on how to apply.
