# Broadband Grant Overview



# **Legal Information**



- Counties are unable to provide high-speed Internet broadband service directly to residents.
- Counties may provide grants to ISPs for the purpose of expanding service in unserved areas. (SL 2012-86)



#### **Definitions**



#### **Unserved**

Unserved locations are areas with speeds less than 25 megabits per second (mbps) download, and 3 mbps upload.

#### Underserved


Underserved locations are areas with speeds between 25 mbps download/3 mbps upload, and 100 mbps download and 100 mbps upload.

Unserved < 25/3


Underserved = Between 25/3 and 100/100

Served > 100/100


# **Unserved Locations**




- Count of Unserved Locations (Less Than 25/3)

## **Served Locations Cable**




#### **RDOF**

**The Rural Digital Opportunity Fund** will provide \$20.4 billion in funding over a ten-year period to support the construction of broadband networks in rural communities across the country.

Eligible areas include those without current (or already funded) access to adequate broadband service, defined as 25 Mbps downstream and 3 Mbps upstream (25/3).

#### **Additional Info:**

- Chatham County RDOF grant is through Charter Communications (Spectrum).
- 6 Year Build Window. (Entering 3<sup>rd</sup> Year of Grant)
- Additional federal funding unable to be used in these areas.
- Locations Served by Grant: 3,448




#### **GREAT Grant**

The **Growing Rural Economies with Access to Technology (GREAT) Grant** is a competitive grant program that provides funding to private sector broadband providers to deploy last-mile broadband infrastructure to unserved areas of North Carolina. The original GREAT Grant program was initiated in 2018 and launched in 2019, and subsequently became a recurring state-funded grant program within the NCDIT Broadband Infrastructure Office.


#### **Additional Info:**

- Chatham County has received two GREAT grants. (Yellow=AT&T and Green=Brightspeed)
- Total Project Cost: \$8.1M
- County Match: \$519,228.20
- Locations to be Served: 2,404



#### **CAB Grant**


The **Completing Access to Broadband (CAB) Program** provides an opportunity for individual N.C. counties to partner with NCDIT to fund broadband deployment projects in unserved areas of each county. N.C. Session Law 2021-180 appropriates \$400 million from the American Rescue Plan Act for this new program.



#### **Additional Information:**

- Counties must work with NCDIT to develop projects
- 35% County Match
- Chatham County Board of Commissioners directed 2.5M to this program.
- Locations to be served: 2,555

#### **Chatham CAB Grant**



#### <u>Info:</u>

- Total Project Cost: \$6,474,134.00
- \$2,500,000 allocated by BOC to Project.
- Average Cost Per Location: \$2,533.91
- Locations to be served: 2,555
- Will serve 40% of 6,400 unserved locations in Chatham County.



#### **Broadband Grant Totals**



- Total Locations Served through broadband grant programs: 8,407
- Estimated percentage of **total** locations served by these programs: <u>27%</u>
- Total Cost of CAB and GREAT Projects: \$14,574,134.00
- Total County Allocation to CAB and GREAT Projects: \$3,019,228.20




# Digital Inclusion Grant

#### **Central Pines Grant**

- Announced on June 18th Central Pines Regional Council received Digital Literacy Grant from NCDIT
- \$800,000 grant to establish <u>regional</u> digital literacy effort in Chatham and Durham Counties.
- The Grant will do the following:
  - Establish classes that will provide digital literacy training and a free laptop (post-training) for around 500 Chatham County Residents and 500 Durham County Residents.
  - Allocate computer carts and laptops to use for digital literacy training in:
    - 1. Wren Memorial and Goldston Public Libraries
    - 2. Siler City and Pittsboro Centers for Active Living

# Digital Inclusion Plan





## What is a Digital Inclusion Plan?



#### Digital inclusion plans assess:

- Tools and resources counties currently have.
- Areas and populations of people who do not currently have access to broadband service (or insufficient, slow connections).
- Resources or strategies needed to fully connect everyone in the region.
- · How to make internet-enabled devices more accessible.
- How to increase availability of digital literacy training.
- Availability of technical support.

#### <u>Availability</u>

Availability in the context of digital inclusion refers to <u>digital broadband</u> infrastructure.

#### Access

Access refers to the ability for someone to gain access to available broadband. The barriers to access include affordability concerns and lack of access to computing devices.

#### <u>Adoption</u>

"Broadband adoption"
means <u>adopting</u>
<u>broadband internet in</u>
<u>everyday life</u>, or in
essential ways such as for
government services,
schooling, or work.





# Continuing the Work

## **Continuing the Work**

- Once adopted, the plan will be reviewed by Chatham County annually for updating based on the following metrics:
  - Availability:
    - 1. The number of preexisting homes provided internet that year.
    - 2. Progress on Grant oriented project development within the year.
    - 3. Gross growth of networks within Chatham County.
    - 4. Annual surveys regarding student/resident internet availability.
  - Access:
    - 1. Change in the number of devices provided across the county.
    - 2. Usership of provided programs, and determination of communities most utilizing provided services.
    - 3. Change in surveys indicating students access to devices.
  - o Adoption:
    - 1. Data on utilization of basic computing classes.
    - 2. Establishment and performance of programs that assist with adoption of broadband technologies.

#### **Process**



- Present plan to Chatham County Board of Commissioners.
- Receive community feedback (Next Slide).
- Use community feedback to review and edit plan.
- Bring edited and finalized Digital Inclusion Plan back to BOC for Adoption.
