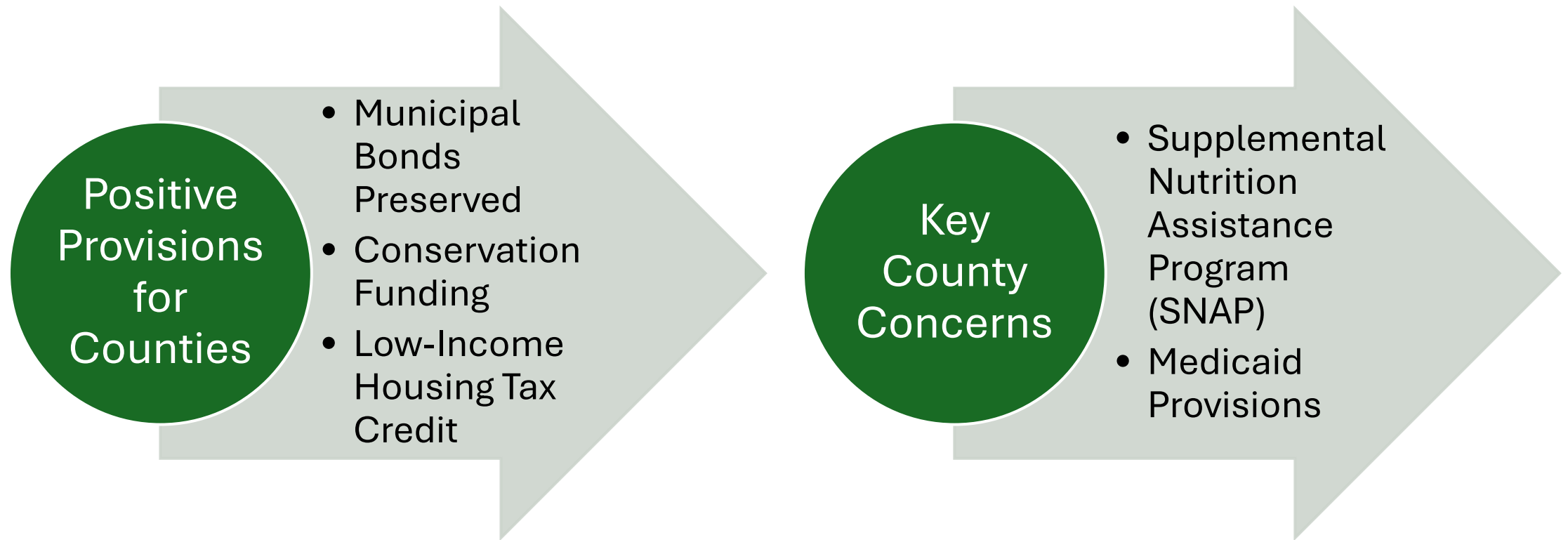

Impacts of OBBBB – SNAP

Cost Shift to States:

NC faces a \$420 million cost increase starting in FY 2027-2028

If the state cannot cover this, the entire SNAP program could be lost

Error Rate Penalties:

Beginning October 2027, NC must pay a share of benefit costs based on error rates.

Even with a below-average error rate, NC will owe 15% of benefit costs.

Current Reach of SNAP in NC:

Serves 1.4 million residents, including:

- 1 in 6 children
- 46,000 veterans
- 4 out of 5 families include a child, senior, or person with a disability

Impacts of OBBBB – SNAP

- Cost Shifts to Counties:
 - NC is one of 10 states that administer SNAP at the local level
 - Beginning in FY 2027 county administrative cost share will increase from 50% to 75%, raising the administrative cost share for the counties in those 10 states to \$2.6 billion



Impacts of OBBBB - Medicaid

Work Requirement Introduced:

- Applies to the Medicaid expansion population
- Increases administrative costs, which current hospital provider taxes cannot fully cover
- NC law must change to fund these costs by the end of 2025

Limits on Provider Taxes:

- New provider taxes are prohibited
- Caps are reduced for existing provider taxes in Medicaid expansion states
- Estimated \$22.5 billion loss to the NC economy from reduced provider tax revenue

Impacts of OBBBB - Medicaid



Cuts to State Directed Payments:

These payments help rural hospitals stay open
The \$6 billion Healthcare Access and Stabilization Program will be eliminated in 2028



Rural Healthcare Fund:

\$50 billion fund created but spread across the entire country – insufficient to offset NC losses



Overall Medicaid Impact:

Estimated \$49.9 billion loss to NC over 10 years
Medicaid expansion is at risk without action from the NC General Assembly

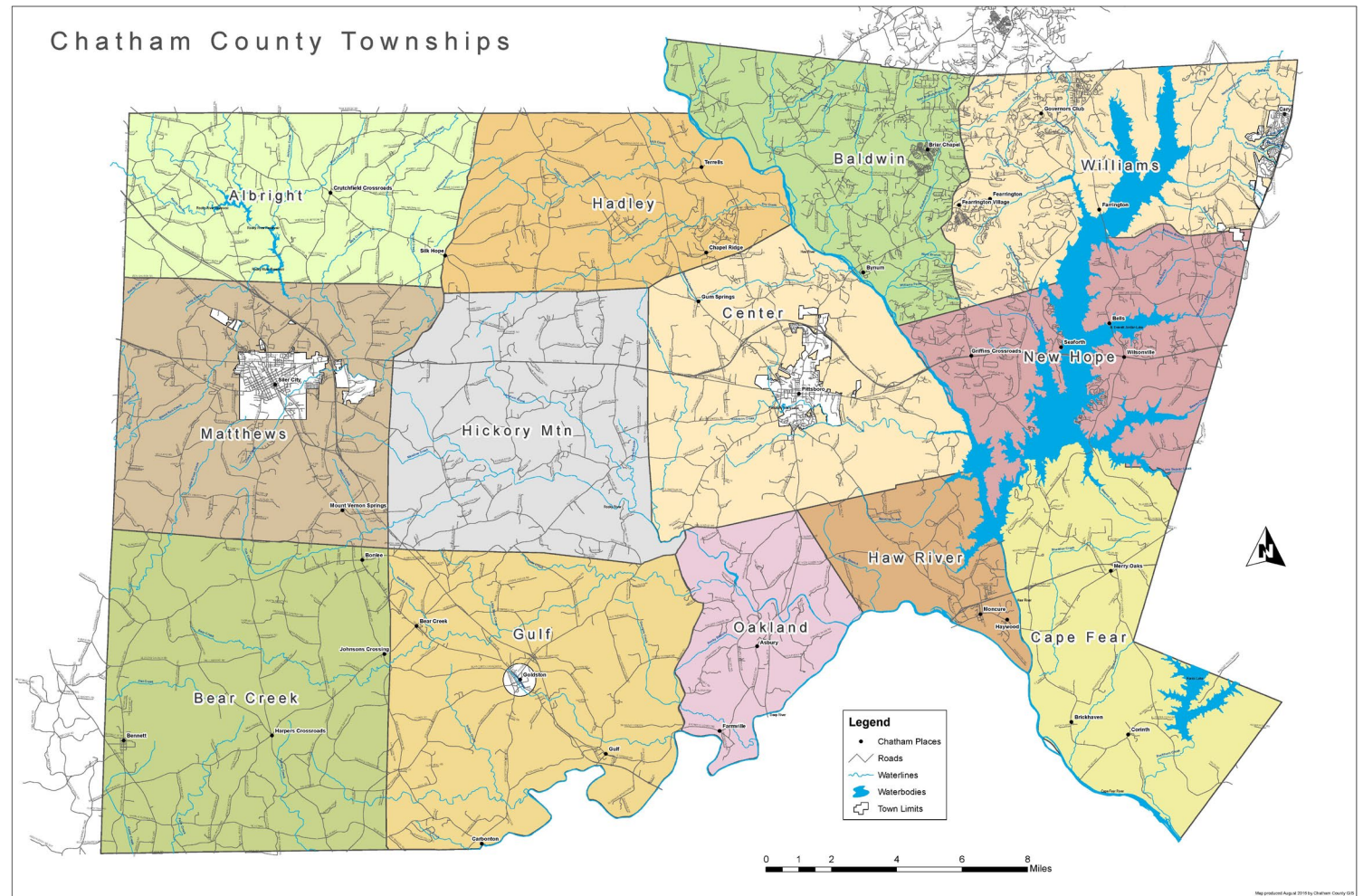
