**AMENDMENT TO AGREEMENT**

**DATED APRIL 8, 2010**

This Amendment to the Agreement (this "Amendment") is made and entered into this   1st   day of   July  , 2016, by and between **CHATHAM COUNTY, NORTH CAROLINA**, a body politic and corporate of the State of North Carolina (the "County") and **WASTE MANAGEMENT OF CAROLINAS INC.** (the "Contractor"). The County and the Contractor are sometimes referred to in this Amendment individually as a "Party" and collectively as the "Parties".

**RECITALS**

- A. The County and the Contractor entered into an Agreement dated and made effective the 8<sup>th</sup> day of April, 2010 (the "Agreement").
- B. The County has requested that the Agreement be amended to change the term, compensation, and hours of operation.
- C. The Contractor has agreed to amend the Agreement as requested by the County.

NOW, THEREFORE, in consideration of the mutual covenants and the conditions contained herein, the Parties agree as follows:

- 1. **EXTENSION OF TERM.** The parties mutually agree to extend the term of the Agreement an additional twelve (12) months, beginning July 1, 2016 and ending at midnight on June 30, 2017.
- 2. **COMPENSATION and EXPENSES.** As compensation for the Services to be provided under this Agreement, the County shall pay the Contractor the total sum as set forth in Exhibit B, attached hereto and incorporated herein by reference. The amounts stated on Exhibit B are all inclusive and include all expenses of every kind and nature.

**AGREEMENT TO REMAIN IN FULL FORCE AND EFFECT.** Except for the amendments set forth above the Agreement dated April 8, 2010, shall remain in full force and effect.
