**I. Background:**

*As of January 1, 2019, this Agreement Addendum Revision #1 adds the following paragraph:*

On August 27, 2018, the US Department of Health and Human Services, Public Health Service Notice of Award, P.L. 91-572 PHS Act Sec. 1001 as Amended, 42 CFR 59, authorized the awarding of Title X funds to the North Carolina Statewide Family Planning Program for FY 18-19. The Notice of Award stipulated the Budget Period for Title X funding had been reduced from twelve months to nine months; thereby reducing the amount of awarded funding.

**II. Purpose:**

This Agreement Addendum Revision #1 reduces, by less than 1%, the funding for this Activity due to the Title X funding budget period reduction by the US Department of Health and Human Services, Public Health Service.

**III. Scope of Work and Deliverables:**

The Local Health Department shall provide information on Attachment E stating how it will absorb the reduction in Title X funds based on locally determined needs and circumstances.


