PUBLIC COMMENT SESSION

Erika Guy

My name is Erica Guy and I'm here today to make a plea. Consider targeting increased financial support to address the critical issue of mental health among our youth and improve what I call glacial mentorship for youth. I'm a lifelong educator, having been a counselor, a Dean of students for 26 years, a classroom teacher, and a coach, I took an early retirement in 2016 and immediately volunteered with local organizations unities in schools for a food pantry, Chatham Middle School. I began at Chatham Middle in 2016 and I ran a weekly social emotional learning student support group for students facing considerable challenges in concert with communities in schools. In 2017, I initiated a cooking matters for teens program at CMS to provide an outlet for students who may not otherwise have had enrichment opportunities. The six-week program ran twice yearly until we hit the buzz saw of COVID happily in 2024. We're back. Yeah, and now working with students at Horton Middle School. We just ran the six-week program. What do I experienced, witnessed and lived over these years? Has convinced United Codes has COVID marble at lesson cytological developmental tasks have been dramatically delayed among our youth. The mental health crisis for them is well documented, but the cost is not yet entirely realized, but I sense found yes, we need to support our teachers financially and in many other ways. And yes, COVID learning loss is considerable, but I would argue that COVID mental health losses are comparable. Both needing attention and funding. I know from experience that kids need caring relationships with alts instances like CIS, Big Brother, Big sister model, improved their relational power works well. I applaud this decision by Community Schools to engage Daybreak. We'd say health agency would focuses on mental health. It does not and cannot take the place of in person connection. A couple of suggestions. Partnering, that's a boarding well established organizations like Big Brother, Big Sister, the Triangle and using. Better trauma based invention increasing this on Monday ring for kids K through 12. My mantra in education has always been relationship for tests or as one of my students once distilled until you know, until I know how much you care, I could care less how much you know. I hope that in concert with all of it available, agencies can achieve the

mission of Chatham County Schools to graduate our students with the ability to make positive choices with collaboration and funding. I think we can interrupt the cycle of emotional poverty. Thank you very much for this.

Receive an update from the Sheriff's Office concerning FY 25 budget

Sheriff Roberson thanked the Board of Commissioners for the pay increases staff has received over the years but stated that they are still way behind in detention and it is creating some compression issues. Roberson stated when he presented a couple of months, he requested more positions over the next four years to both catch up and keep up with growth. Roberson stated that Renee Paschal is working on a strategic plan for the Sheriff's Office, and he hopes to present a better plan in the next budget year that includes staffing and buildings. He stated that he needed forty more deputy positions, but they cannot be hired in a year, so they are asking for ten deputy positions over the next four years to help deal with and keep up with the growth. Roberson stated that there are other positions requested in the budget and he asked Operations Analyst Connor Wilkins to come forward and present the remainder of the budget.

Wilkins started with the baseline in fiscal year 24, the total Sheriff's Office budget encompassed almost \$21 million. The budget is broken up into three different sections with the sheriff's main budget, the detention budget, and the Animal Resource Center. The sheriff's budget main budget is about \$12.6 million and as a proportion of all three budgets it takes up 60 1/2%, with the Detention Center budget at \$6.4 million which is around 31% and the Animal Resource Center budget is about \$1.7 million which is about 8.6 total percent. The fiscal year 25 request is about \$25.79 million.

Wilkins broke down the details of the increase which included twenty-three positions requested, with thirteen being new deputies, the cloud storage upgrade on the Watchguard system, and an Animal Resource Center surgery suite. Wilkins shared the cost breakdown of a deputy and other major highlights which include ancillary cost of new positions, consolidation of cell phones, and increase in travel and training.

Sheriff Roberson stated that he knows those are big numbers, but he wanted to be realistic.

Commissioner Delaney stated that he remembered the end of the January session with you and the staff, we talked through a little bit about the process to get employee hired and the challenges to go through the law enforcement training course, do you see any real difficulties with being able to get candidates, get them qualified and get them through that cycle. Roberson replied if they are able to get the money for the new hires and over the past two years they have changed the hiring process, which has helped. He said if he would have received funding for fifteen positions last year, he probably would have to turn it down because candidates have been hard to find. But he is caught up now and they only have six vacancies currently.

Commissioner Gomez-Flores asked could you touch on the different sources of funding that you receive from and is there any particular area of funds that you can get additional funding? Sheriff Roberson replied that he was not aware of any alternate sources of funding.

The Board of Commissioners thanked the Sheriff and staff for the presentation.

Receive an update from Chatham County Schools concerning the FY 25 budget

Chatham County Schools Superintendent Dr. Anthony Jackson presented an updated budget request from Chatham County Schools. Jackson spoke of the five-year strategic plan and shared the progress with the Board of Commissioners and the school system has embraced One Chatham. Jackson stated after the presentation in January, the school system received updates from the state and the challenges around workforce and student learning are real. The employee supplement and compensation have been an ongoing conversation. Jackson noted that the school system wants to be in the top ten in the state, but they want to make sure that they have a sustainable model. Since January, the conditions have changed and they are no longer in the top ten, they have dropped to twelve, but Chatham continues to be the most competitive in the region for supplements. They are continuing to hear from teachers that are leaving even with the average supplement in Chatham County is over \$7,000 above the state salary. Jackson reviewed the comparison with surrounding counties and the data is showing that Chatham is not unique in teachers leaving.

Chatham County Schools Finance Officer Tony Messer continued the presentation. Messer stated that Chatham County Schools is requesting an increase in the salary supplement since the request in January.

Vice-Chair Howard clarified that it's just the supplement request changing and not the full budget request. Jackson replied yes.

Chair Dasher asked what the expectation is when we raise supplement, how do we keep up with the other county increases. Jackson stated that this is a market-driven business, and they try very hard not to give any surprises. Their request is data-driven and when they got updated numbers in March, they discovered they had fallen out of the top ten for one of their metrics. The surrounding counties are starting to struggle with how to make up the gap that will be left by the ARPA funds and the Board of Commissioners helped the Board of Education do that last year and they are grateful.

Vice-Chair Howard stated that the state pays teacher's salaries, and the state is not valuing and investing in public education so Chatham County continues to be put in a position to compete with surrounding jurisdictions. There are other benefits to teaching in Chatham and that is why we see people stay. We must put more pressure on the state.

Commissioner Delaney commented that the state is not interested in continuing state funded public education. One challenge he has with this big supplemental request now, is our county property tax is regressive. Our lower property tax owners are experiencing a greater burden. Any tax increase, even a small increase, is more impactful on those lower of valued properties and their owners. He would love to be in the long-term plan with everyone to have good healthy options over multiple years.

Commissioner Delaney stated at the retreat he asked Dr. Jackson what they would

do with \$1Million for mental health and could some of this supplement to student mental health. Jackson replied that was a conversation for the Board of Commissioners and the Board of Education. Vice Chair Howard replied that the Board of Commissioners are responsible for funding the schools not setting their polices, that is the responsibility of the Board of Education.

Commissioner Kenlan stated that the Board of Commissioners have a wonderful relationship with the Board of Education and thanked them for all the work they have done with the strategic plan. Jackson stated that it is a priority for teachers, staff, parents, and community stakeholders.

The Board of Commissioners thanked Jackson and Messer for the presentation.

Receive an update on the Unified Development Ordinance Project and vote to approve budget increase

Planning Director Jason Sullivan, Assistant Planning Director Chance Mullis, and Consultant Tyson Smith gave a presentation to the Board of Commissioners concerning the Unified Development Ordinance. The presentation included the current status, recode Chatham progress, and two-year timeline. Mullis shared the code approaches including the Health and Equity Assessment and Plan Moncure. Mullis shared the drafting and review timelines, the updated timeline and budget, and reviewed the protocol process.

Mullis reviewed an updated Unified Development Ordinance budget with the Board of Commissioners and requested that the in contingency be used to complete the project. Mullis also requested that the Board of Commissioners affirm the schedule and extend the contract until January 31, 2025.

Commissioner Kenlan stated that she would like to get that information out to the advisory committees to let them know they can contribute to the process, including the Environmental Review Advisory Committee and the Agriculture Advisory Committee. Mullis stated that the committee already know, and several have been very active.

Commissioner Gomez-Flores asked does staff thinks the subcommittee is balanced? Mullis replied yes.

Sullivan presented an updated budget and options for consideration and the requested action for the Board of Commissioners

Staff noted that a budget amendment for this item will be placed on a future consent agenda.

Smith shared the zoning map update, the draft Unified Development Ordinance table of use aligning the full plan to Plan Moncure. Smith stated that for the adopted Unified Development Ordinance to be implemented per the policy direction of Plan Chatham, Plan Moncure, and the Health and Equity Assessment, the county will need to initiate rezonings in early 2025. The county will have large amounts of rezonings across the county to match the new zoning districts in the Unified Development Ordinance. Smith stated that it is important to think about as we head towards adoption because of the public interest that will be received when the public notice of the rezonings begins tin early 2025.

Chair Dasher asked if there a way to have scenario maps. Smith replied that staff will work on some options.

Mullis shared the Unified Development Ordinance next steps and timeline which included the next modules. Mullis stated that module 3 procedures are the subcommittee reviewed part of module 3 on March 28th and will review the remaining chapters April 25th, will be reviewed by Planning Board and the Board of Commissioners in July. Module 4: definitions have been reviewed as an ongoing process and they will be review by Planning Board and the Board of Commissioners in July, then will be consolidated in the draft, which is expected to be reviewed by Board of Commissioners and the Planning Board in September, then the Board of Commissioners and Planning Board will review and adopt UDO, which is expected in October to November.

Commissioner Gomez-Flores asked about building height standards. Mullis replied that a lot of those standards are in module 2 which was posted online today and will be presented to the board May 6th.

Commissioner Kenlan asked if there could be a one-on-one with the Board Members and staff before reviewing Module 2 at the next meeting. Mullis stated that they would be happy to meet with commissioners individually.

Commissioners Gomez-Flores asked if Staff could create a video to watch before the presentation on May 6th. Mullis replied yes, they can use Microsoft Teams or the voice over option on PowerPoint and get a video to them prior to the meeting.

The Board of Commissioners thanked staff for the presentation.

Receive a presentation from Triangle Lands Conservancy Farmland Preservation Program

Margaret Sands, Associate Director of Land Protection West and Kierra Hyman, Good Ground Manager, both with Triangle Land Conservancy presented an update on the Chatham County agricultural preservation.,

Sands stated that Triangle Land Conservancy has eight public nature preserves and over 25,000 acres conserved in the triangle. Triangle Land Conservancy works with willing landowners to acquire conservation easements on working farms and forests by creating a voluntary legal agreement that limits use inconsistent with agricultural production and conservation values. The landowners still own the land and can use, sell, or pass land on to heirs and the conservation easements do not allow public access. Triangle Land Conservancy typically acquires conservation easements using some combination of federal, state, and local dollars plus landowner donation (a "bargain sale") and their staff monitor conservation easements annually to ensure they are followed and continue landowner relationships.

Sands shared the benefits of conservation easements and their connection to Chatham County's Comprehensive Plan. Sands shared an overview of working lands and a farm list in the county.

Hyman shared an overview of the Good Ground Initiative where Triangle Land Conservancy strives to turn organizational resources and power into equitable land distribution by empowering partners and investing resources in education and land access for historically underserved land seekers. This program is a community collaboration for land access, conservation, and equity.

Sands gave an overview of the opportunities in Chatham County of lands to conserve. Sands also asked the Board of Commissioners to consider committing rollback taxes to the Chatham Agricultural Preservation and Development Trust Fund.

The Board of Commissioners thanked Sands and Hyman for the presentation.

Receive a presentation and vote to approve Chatham Agricultural Preservation & Development (CAPD) Trust Fund Recommendations from the Agricultural Advisory Board and Chatham Soil & Water Conservation District Supervisors

Andrew Waters, Farmland Preservation Coordinator with Chatham County Soil and Water Conservation District presented the Chatham Agricultural Preservation & Development Trust Fund recommendations from the Agricultural Advisory Board and Chatham Soil & Water Conservation District Supervisors.

Waters stated that Chatham County is losing prime farm and forestry land at an alarming rate. According to a recent study by the American Farmland Trust, Chatham County is projected to lose 44% of its working landscapes by 2040, ranking it as one of top five North Carolina counties in projected loss of working landscapes.

Waters stated that the Chatham Agricultural Preservation & Development Trust Fund was unanimously approved by the Chatham County Board of Commissioners on October 17, 2022, to support agricultural preservation and development within Chatham County. Funding for the Chatham Agricultural Preservation & Development Trust Fund was designated in the Article 46 tax referendum that was approved by Chatham County voters in the March 2020 voter referendum. The purpose of the Chatham Agricultural Preservation & Development is to provide project support and acquisition funding to local and regional land trusts, who will acquire, hold, and steward the conservation easements. With the Commissioners approval on October 2, 2023, the Chatham Agricultural Preservation & Development Trust Fund opened its first application round in December 2023 for farmland preservation projects in Chatham County.

Waters stated after a successful Chatham Agricultural Preservation & Development grant application period this winter, the Chatham County Agricultural Advisory Board (February 13, 2024, meeting) and the Chatham Soil & Water Conservation District Supervisors (March 14, 2024, meeting) have voted to recommend funding of the following four grant applications:

Project A: A permanent conservation easement acquisition on 87 acres of working

farmland off Otis Johnson Road in northern Chatham County. Chatham Agricultural Preservation & Development funding of \$12,000 is recommended for legal defense/stewardship endowment funding.

Grantee: Triangle Lands Conservancy

Matching Grants (pending): North Carolina Agricultural Development and Farmland Preservation Trust Fund

Anticipated project closing date: Summer/Fall 2025

Project B: A permanent conservation easement acquisition on 75 acres of working farmland off Silk Hope/Gum Springs Road in north central Chatham County. Chatham Agricultural Preservation & Development funding of \$140,000 is recommended for conservation easement acquisition and \$10,000 for legal defense/stewardship endowment funding.

Grantee: Triangle Lands Conservancy

Matching Grants (pending): North Carolina Agricultural Development and Farmland Preservation Trust Fund

Anticipated project closing date: Summer/Fall 2025

Project C: A permanent conservation easement acquisition on 120 acres of working farmland off Highway 87 in north central Chatham County. Chatham Agricultural Preservation & Development funding of \$438,000 is recommended for conservation easement acquisition.

Grantee: Triangle Lands Conservancy

Matching Grants (proposed): Town of Cary Watershed Protection Fund

Anticipated project closing date: December 2024 (if matching grant received)

An organizational support grant for the Triangle Lands Conservancy (TLC) of \$75,000 is recommended to support their farmland preservation work prioritize and programming in Chatham County.

Grantee: Triangle Lands Conservancy

Project Term: FY2025 (July 2024-June 2025)

Waters noted that the conservation easement acquisition grants are submitted as matching funds and are contingent on the outcome for other pending grant applications. Waters also noted that the recommendations will dedicate \$675,000 in funding from the Chatham Agricultural Preservation & Development, which has a current balance of approximately \$1.2 million in funding that has accrued since the Article 46 revenue referendum was passed by voters. Existing Chatham Agricultural Preservation & Development funds of \$75,000 will be appropriated to the 2025 Budget for the Organizational Support Grant. Funding for Projects A, B & C will not be appropriated at this time, pending approval and issuance of matching grant contracts and project due diligence. Conservation easement acquisition funding will be distributed to the grantee (Triangle Land Conservancy) at closing.

The Board of Commissioners asked questions of Waters and thanked him for the presentation.
