**WHEREAS**, Drake has already begun making an impact in Brooklyn, including surprising youth athletes at a local basketball clinic, showing leadership and a commitment to giving back to the community—values that reflect the strong foundation and support instilled in him by his family and especially his parents, Dedric and Cherice Powell, whose unwavering encouragement, guidance, and dedication have played a vital role in his development on and off the court; and

**WHEREAS**, Drake's pride in his home community and North Carolina roots continues to be evident as he joins other former Tar Heels in the NBA, inspiring young athletes across Chatham County and beyond;

**NOW, THEREFORE, BE IT RESOLVED**, that the Chatham County Board of Commissioners hereby honors and congratulates Drake Powell on his selection in the 2025 NBA Draft and commends him for his outstanding athletic achievements, dedication to personal growth, and exemplary representation of Chatham County on the national stage.
