INTERLOCAL AGREEMENT  
WITH CHATHAM COUNTY

THIS AGREEMENT, made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2016, by and between the City of Sanford, a North Carolina Municipal Corporation, (hereinafter referred to as “City”) and the County of Chatham, one of the one hundred counties of the State of North Carolina and a body both politic and corporate, (hereinafter referred to as “County”).

WITNESSETH:

WHEREAS, the Moncure Megasite is located in Chatham County and the City of Sanford owns and operates a wastewater collection and treatment system with a capacity currently capable of treating wastewater from the Moncure Megasite and other portions of Chatham County; and

WHEREAS, the City of Sanford believes the development of the Megasite in this location will provide significant positive economic impacts for the region; and

WHEREAS, The Golden L.E.A.F. Inc., will make grants to fund construction or improvement of public infrastructure that serves publicly-owned or publicly-controlled industrial sites that have the potential to attract employers that can create a large number of jobs and have a significant positive effect on the local, regional, and state economy; and

WHEREAS, The Golden L.E.A.F. Inc., has funds available for a Major Site Development Initiative (MSDI) to reduce the time that it would take for employers to complete site development and begin operations on large sites that must be served by public infrastructure, such as water and wastewater; and

WHEREAS, The Golden L.E.A.F. Inc., has invited the City of Sanford to submit an application for wastewater improvements; and,

WHEREAS, the City of Sanford and the County of Chatham have agreed to cooperate on acquiring a grant from The Golden L.E.A.F. Inc.; and

WHEREAS, North Carolina General Statute §160A-461 authorizes units of local governments to enter into agreements with each other in order to execute undertakings.

NOW, THEREFORE, in consideration of the premises, the mutual promises herein contained, and the sum of ten dollars, in hand paid, the receipt of which is hereby acknowledged, the parties hereto have mutually agreed as follows:

1. The City of Sanford and Chatham County agree to cooperate and participate in activities necessary to provide infrastructure to facilitate the development of the Moncure Megasite, as a significant industrial site, creating jobs for the region.

2. Provided adequate funding can be obtained, the City of Sanford agrees to design, contract, construct, own, operate and maintain the proposed wastewater infrastructure to provide wastewater collection and treatment for the site.
3. Chatham County agrees to use all means available for acquisition of adequate interests in land necessary for the installation, operation and maintenance of wastewater infrastructure within Chatham County.
4. The City of Sanford agrees to use all means available for acquisition of adequate interests in land necessary for the installation, operation and maintenance of wastewater infrastructure within Lee County.
5. Chatham County agrees to support, cooperate, participate and expedite activities to facilitate timely development of the site.
6. The provisions of this agreement are contingent upon the successful award of the grant described above.
