Please include addendum acknowledgement in your submittal.

1. **Q:** Please confirm discrepancy on drawing for full-depth pavement repair specification; 8" compacted ABC and 2" I-2, or 8" compacted ABC and 3" SF 9.5B.

A: Bidders should use the written specifications in the Request for Bids detailing 8" compacted ABC and 2" I-2 or equivalent for the full depth pavement repair. I have changed the note on the drawing and attached the revised drawing to this addendum

2. Q: Since the siding on the front of the swap shop building overlaps the concrete ramp, refer to pictures from previous project for how to work around this.

A: Picture is included in this addendum-Attachment A.

3. **Q:** What type of stone should be used to replace the grass for the island?

A: As shown on the drawing and detailed in Notes 3 and 4, a portion of the island around the compactor pad and building will receive #57 stone and the portion that currently has bushes planted will receive white marble stone. On the drawing, the portion receiving white marble stone is hatched.

4. **Q:** What are the operating hours of the collection center? When is the best time for construction to take place?

A: Hours: Open Monday, Tuesday, Thursday, Friday and Saturday 7 am - 7 pm. Closed: Wednesday and Sunday.

B. Wednesday is the best day for work as the center is closed to the public. Coordination with Kevin Lindley will be required if the work will be performed on Wednesday.

C. Busiest days are Monday and Friday.

D. If work is performed during operating hours, cone off section of work space.

5. **Q:** Will the dumpster be relocated for cutting?

A: Yes, the dumpster that is in the area for the new concrete pad will be removed by the County prior to work commencing on the new concrete pad. Contractor will mark corners where pavement will be cut and receive County approval for pad location before cutting the existing pavement.

6. Q: How does the County plan to navigate the center not being closed for a consecutive period long enough to allow for the concrete and asphalt to cure? Is it possible to work through Tuesday night to allow more cure time?

A: The asphalt cure time has not been an issue on previous projects. When the work is done on a Wednesday the center has been open regular hours the following day, for example. The concrete pad will need to be coned off during the curing time to prevent traffic or other disturbance to the pad before reaching adequate working strength.

7. Q: Is there a place in which lights can be plugged in?

A: No, there are no exterior outlets available in the center.

8. Q: Will there also be access to water on site?

A: Yes, there is a yard hydrant adjacent to the attendant building in the center of the site.

9. Q: Will the County require copies of disposal tickets for all other construction debris that is not disposed of at 28 County Services Road location?

A: We will not require copies of disposal tickets.

10. Q: Please confirm the work hours are 7am-7pm.

A: See the answer to question 4.

11. Q: Please confirm that any dumpster blocking the construction area will be removed prior to mobilization.

A: See the answer to question 5

12. Q: Is the contractor responsible for both the removal and disposal of the bushes in the island?

A: The County's Facilities department will remove the bushes to repurpose them. If the bushes are not removed by the time construction begins, please remove them and put them aside for Facilities to pick up.

B: Include the bush removal in your bid in case Facilities does not remove them ahead of time.

13. Q: Regarding the geotextile layer to be installed in the island, would Mirafi HP-570 be an acceptable equivalent to the Mirafi 140 N?

A: For the purposes of this project, that would be an acceptable equivalent.

14. Q: Referring to milling the existing asphalt at the edges of all new and existing concrete pads and pavement, is there a footage preference by the County (i.e. 2 feet, 4 feet, etc.)?

A: A two-foot milling width should be sufficient.

15. Q: Please specify what is being covered in the one year warranty on the living plants.

A: The one year warranty would be to replace any plants that die within one year after the date of substantial completion. County staff will water the plants on a regular basis, as needed.

16. Q: Are the E-verify, Iran Divestment Act and Israel Boycott forms to be submitted with the bid?

A: Yes. Certification statements are included in the addendum.


