Dear Members of the Chatham County Board of Commissioners,

Enclosed please find the information pertaining to recent revisions made by the Chatham County Schools Board of Education to the Head-Up Assumptions, which we believe are essential for your consideration in the development of the county's budget.

The Chatham County Board of Education, through unanimous decision on Monday, March 11, 2024, has directed our team to revise and submit updated assumptions for our 2024-2025 Preliminary Heads-Up Budget Request Document.

These revisions stem from the imperative need to address the challenges surrounding recruitment, retention, and equitable compensation of our highly skilled educators, critical for the provision of quality education to the students of Chatham County. Notably, the revised request includes an increase of \$2,700 to the base of each step of the supplement pay schedule.

Aligned with our ONE Chatham strategic plan, these adjustments aim to ensure that our educators are well-qualified and fairly compensated, thereby fulfilling our commitment to providing exemplary education to every student in our district.
