Good morning, Jennifer,

It was nice meeting you as well this morning. Per my conversation with you this morning, the Chatham JCPC voted in approval of increasing the JCPC DJJ allocation from \$60,000 to \$73,333 to Communities in Schools Community Service & Restitution program at our meeting on September 5, 2025. At the beginning of this fiscal year, there was an amount of \$13,333 unallocated in which Communities in Schools submitted a request to enhance the program by offering educational workshops to the referred youth.

Communities in Schools has submitted a budget revision reflecting the increase in the JCPC allocation which is making its way through electronic signature approvals in our NCALLIES system. I am requesting that the Chatham County Board of Commissioners review and sign the attached updated county funding plan at their next meeting on December 15, 2025, so that the increase in allocation from NCDPS and county match is appropriated.

Please let me know if the Board of Commissioners require additional information prior to the December 15, 2025, meeting.
