RESOLUTION OF SUPPORT FOR TRIANGLE AREA RURAL TRANPORTATION PLANNING ORGANIZATION (TARPO) ASSIGNMENT OF LOCAL POINTS NC STRATEGIC TRANSPORTTION (STI) PRIORITIZATION 3.0 PROCESS

WHEREAS, Chatham County is a member of the Triangle Area Rural Planning Organization (TARPO); and

WHEREAS, the TARPO Rural Transportation Advisory Committee has approved a process for assigning "local input points" to transportation projects in the North Carolina Strategic Transportation Investments (STI) Prioritization 3.0 Process based on data, input from local communities, and input from the public; and

WHEREAS, the application of this process has resulted in a draft list of projects that would receive local input points from TARPO, which is posted online at www.tarpo.org/topics/spot3.shtml; and

WHEREAS, the draft point assignment list is in accordance with the current transportation needs and desires of Chatham County;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Chatham supports the Triangle Area Rural Planning Organization's proposed assignment of local input points to projects as part of the Strategic Transportation Investments Prioritization 3.0 Process.

Projects Recommended for TARPO Point Assignment in Regional Impact Category:

H090560 - Hillsboro St (US 15-501) widening to 3 lanes with curb/gutter, bike lanes and sidewalks, from Launis St to Powell Place

H140366 - US 64 (11th St) in Siler City - add median and bicycle/pedestrian improvements, from US 421 Bypass to Greensboro Ave

H090562 - Sanford Rd (US 15-501) widening to 3 lanes with curb/gutter, bike lanes and sidewalks, from Robeson Creek to NC 87

H090302 - NC 87 widening to provide 12-ft lanes and 4-ft paved shoulders, from NC 902 to Alamance County line

Projects Recommended for TARPO Point Assignment in Division Needs Category:

A130467 - Easement acquisition & obstruction clearing at Siler City Municipal Airport

 $\rm H090560$ - Hillsboro St (US 15-501) widening to 3 lanes with curb/gutter, bike lanes and sidewalks, from Launis St to Powell Place

H140366 - US 64 (11th St) in Siler City - add median and bicycle/pedestrian improvements, from US 421 Bypass to Greensboro Ave

B140575 - Multi-use sidepath on E Raleigh St in Siler City from US 64 to S 10th Ave, and sidewalk on E Raleigh St from S 10th Ave to S 6th Ave
