








Proposed Interchange

Kimley-Horn is currently engaged in the planning and preliminary design for a proposed interchange on US 421 north of Siler City, as well as a new 1.1 mile connector road from the Chatham-Siler City Advanced Manufacturing Site to the new interchange. The purpose of the proposed interchange and connector road is to provide truck access from the four-lane divided highway to the site. The interchange is currently included in the draft Chatham County Comprehensive Transportation Plan.

This is a preliminary site plan based on limited information and therefore may not reflect final site features. Minimal site research has been conducted. Site conditions may change significantly.








Contract

- Assures public purpose requirement for county funds






Strategic Action Plan Goals


EDC Budget Goals

- Entrepreneurship: Create jobs and wealth within the county through new business formation




Chatham BOC Vision


Reporting

- Thereafter, contract will be considered annually (so changes can be made)







Is it 10 Days or 24 Hours?



ARTICLE II. SECTION 4.


*...**not less than ten nor more than sixty days** before the date of any meeting,*

ARTICLE IV. SECTION 3.

*The person or persons calling a special meeting of the Board of Directors shall, **at least twenty-four hours before the meeting,** give notice thereof by any usual means of communication.*



Purpose of Special Meeting



ARTICLE II. SECTION 4.

*In the case of a special meeting, the **notice of meeting shall specifically state the purpose or purposes** for which the meeting is called;*


ARTICLE IV. SECTION 3.

*Such **notice need not specify the purpose** for which the meeting is called.*

ARTICLE VII. SECTION 5.


*These bylaws may be altered, amended or repealed and new bylaws may be adopted by vote of two-thirds of the Board of Directors at any meeting or **at any special meeting when the proposed amendment has been set out in the notice of such meeting.***

What's a quorum?



- “**One half plus one of the voting directors** shall constitute a quorum for the transaction of business at any meeting of the Board of Directors.”
- $15/2=7.5$
- $7.5+1=8.5$
- Round up? Round down?



Nomination Process



Board of Directors
Article III. Section 3.

Each County Commissioner may nominate a candidate for a director position to be approved by the Board of Commissioners.

Each of those directors shall be appointed to serve a four year ***term to run concurrent with the current term of the County Commissioner*** who nominated that director.



Nomination Process




Board of Directors
Article III. Section 3.

The Chatham County Commissioners shall make their appointments from a roster of candidates who have ***completed the formal application and review process conducted by the Board of Directors...***

...based on a ***process and qualifications agreed to by the Board of Directors of the corporation and the Chatham County Board of Commissioners.***



Expiration of Terms




Board of Directors
Article III. Section 3.

All terms shall expire at the conclusion of the ***first Monday in March*** following the bi-annual election of County Commissioners or when their replacement has been appointed by the County Commissioners, whichever occurs last.



Monthly Meetings




Board of Directors
Article III. Section 4.

*Failure to attend **three monthly board of directors' meetings** in a row or four monthly directors' meetings during a twelve-month period shall be grounds for removal of a voting director of the corporation by the Chatham County Board of Commissioners.*




Summary



- Commissioners do not have designated EDC board of directors designees.
- The review process was deemed invalid previously.
- Terms of directors do not align.
- We do not have monthly meetings.



Recommendation



- Form a work group.
 - In-depth review.
 - Revise the EDC bylaws.
- Legal Review.
- Submission to EDC Board of Directors for approval.
