## Introduction & Background:

The purpose of the Transportation Advisory Committee (TAC) is to identify and study issues and make recommendations to the county commissioners on transportation and related issues. The long- term goal is to have a sustainable transportation system that offers access to various modes of transportation for people and goods.

The TAC falls under the approved Advisory Committee Policy. Has a total of eleven (11) voting members and up to eight (8) non-voting members.

Each commissioner appoints two (2) voting members from a list of recommended candidates to ensure geographic representation.

The non-voting members (up to eight) may represent Chatham County government, Chatham Transit Network, incorporated towns in the county or other appropriate organizations.

The voting members also should have knowledge or experience in one or more of the following: Nonmotorized transportation, public transportation, personal motor vehicles, large, slow-moving or commercial vehicles, public safety, transportation & the economy, transportation & the environment, transportation and society (community).
