**SPECIAL WARRANTY DEED**

The designation of Grantor and Grantee as used herein shall include said parties, their successors and assigns, and shall include the singular, plural, masculine, feminine, or neuter as required by context.

**W I T N E S S E T H:**

That the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has given, granted, bargained, sold and conveyed, and by these presents does give, grant, bargain, sell and convey unto the Grantee, its successors and assigns, all that certain tract of real estate located in Chatham County, North Carolina, and more fully described as follows:

BEING known and designated as Unit No. 112, as described on a Plat entitled, “Condominium Plat SILER BUSINESS PARK Lot 9 Condominium Plat”, dated April 19, 2005, prepared by Van R. Finch, RLS, and recorded in Condominium Plat Book 1, Pages 30 and 31, Chatham County Registry, to which Plat reference is hereby made for greater certainty of description.

TOGETHER WITH with and subject to all rights and easements appurtenant to said Unit as specifically enumerated in the Declaration of Unit Ownership and Restrictive Covenants for Siler City Business Park Condominium, recorded in Book 1184, Page 779, in the Chatham County Registry.

The property described herein does not include the primary residence of Grantor.

TO HAVE AND TO HOLD the above-described tract of real estate, with all privileges and appurtenances thereunto belonging, to the Grantee in fee simple.

The Grantor covenants with the Grantee, that Grantor has done nothing to impair such title as Grantor received, and Grantor will warrant and defend the title against the lawful claims of all persons claiming by, under or through Grantor, other than the following exceptions:
