*Representatives from the Capital Area Metropolitan Planning Organization (CAMPO) presented an overview of the organization. The Representatives included Executive Director Chris Lukasina, Deputy Director Shelby Powell and Deputy Director Alex Rickard.*

*The representatives stated that Capital Area Metropolitan Planning Organization is comprised of elected officials and staff representing six counties and twenty-one municipal jurisdictions, plus North Carolina Department of Transportation and GoTriangle. The counties include all of Wake and parts of Chatham, Franklin, Granville, Harnett, & Johnston. The combined 2021 population of the coverage is 1.4 million, which is approximately twelve percent of North Carolina. A new Memorandum of Understanding adoption is currently underway for Chatham County.*

*The Capital Area Metropolitan Planning Organization's committees typically meet monthly, with breaks in July and December. The Executive Board is comprised mostly of member governments' elected officials, North Carolina Department of Transportation board member(s), and other agency representatives. The Technical Coordinating Committee is comprised of government and agency staff members and advises the*

*Executive Board on technical issues.*

*The Capital Area Metropolitan Planning Organization funding for planning includes the following:*

- 1. Planning funds allocated by the Federal Highway Administration to Metropolitan Planning Organizations based on population and are administered by North Carolina Department of Transportation Planning Division.*
- 2. Surface Transportation Block Grant Program- Direct Attributable, which are supplied by United States Department of Transportation to Metropolitan Planning Organizations with 200,000 or more population. These funds are meant to cover additional planning and project requirements of larger urban areas. These funds are programmed in the Unified Work Program and through LAPP.*
- 3. State Planning Research Funds - These funds are available through North Carolina Department of Transportation for use on special studies or planning efforts and typically applied to the large regional planning studies. The application process is through the North Carolina Department of Transportation Planning Division.*
- 4. Federal Transit Administration Funds - these funds are from Sec. 5307, 5310, and 5339. These funds are used by transit agencies to conduct planning work. The use of these funds for planning is included in the Metropolitan Planning Organization Unified Planning Work Program.*
- 5. Wake Transit Funding - Funds allocated through the annual Wake Transit Work Program. These funds are used to fund Wake Transit staff annually, with special allocations for periodical plans and studies. Wake Transit Plan is updated every four years.*

*The Locally Administered Projects Program include Metropolitan Planning Organization's with 200,000+ population that receive direct designated Federal funding (State Planning Research Funds-Direct Attributable, Transportation Alternatives Program-Direct Attributable, which was created in 2011 to give Capital Area Metropolitan Planning Organization a technically sound, equitable method of project funding. This is a holistic approach to identifying and prioritizing small but highly effective projects and to avoid future Federal rescissions to the maximum extent possible.*

*The Locally Administered Projects Program Staff works with the Locally Administered Projects Program Selection Committee to maintain a project prioritization system and schedule, evaluate annual submissions and recommend projects, establish annual guide for modal investment mix, quantitative based scoring criteria by mode, only scored within mode. The projects ranked based on local priority, Metropolitan Transportation Plan compliance, prior agency funding level, project effectiveness, and cost effectiveness.*

*Locally Administered Projects Program key dates include spring Locally Administered Projects Program Steering Committee recommends technical criteria and target modal mix, summer Executive Board reviews criteria and modal mix, and opens comment period, August Locally Administered Projects Program call for projects opens, October Locally Administered Projects Program call for projects closes, November through December projects reviewed and scored by staff and the Selection Panel, and in January and February, the Executive Board considers recommended list for approval.*

*A Comprehensive Transportation Plan is a multi-modal long-range vision plan that defines an organization's philosophy towards decisions related to the integration of transportation and land use for highway plan, public transit and rail plan, bicycle and pedestrian plan. The plan depicts transportation infrastructure needed to handle the*

area's projected traffic for a minimum thirty to fifty year planning horizon and planning beyond the Metropolitan Transportation Plan horizon years.

*A Metropolitan Transportation Plan is federally mandated to emphasis on preservation and efficiency improvement of existing system, planning horizon of at least twenty years, but twenty-five is preferred, plans for all modes of transportation, fiscally constrained; not a wish list, and has extensive public involvement. Planning activities that feed into the Metropolitan Transportation Plan large area studies include corridor studies, and hot spot studies. Other special studies or modal studies include local land use and transportation plans and transit plans.*

*The Unified Planning Work Program serves as both the annual budget and the guide to work tasks for the Metropolitan Planning Organization staff. The Unified Planning Work Program Core Mission Work Tasks include developing and maintaining the required transportation planning documents such as the Comprehensive Transportation Plan/Metropolitan Transportation Plan and TIP, assist with the effective disbursement of LAPP program. The Unified Planning Work Program Non-Core Mission Work Tasks include partnering with local or state member agencies to advance transportation planning efforts in a particular area or corridor, which generally require additional local match from beneficiary member jurisdictions and/or other partner agencies/organizations.*

*FY 2025 Unified Planning Work Program and Metropolitan Planning Organization Self-Certification is for new studies including Capital Area Metropolitan Planning Organization / Durham Chapel Hill Metropolitan Planning Organization Joint Rail Strategy Study, Northwest Area Study, Bus Rapid Transit Regional Transportation Plan – Clayton Concept of Operations Study, and implementation of the updated Metropolitan Transportation Plan Bicycle Pedestrian Element.*

*The continuing studies for FY 2024 include the Apex Railyard Relocation Study, Capital Area Metropolitan Planning Organization Regional Multi-Modal Safety Action Plan, NW Harnett Transit Feasibility Study, Wake Transit Plan Update, and the Triangle Bikeway National Environmental Policy Act / Design.*

*The member share budget is \$0.74 - \$0.77 per Capita and the indirect cost estimate is \$175,000.*

*Other Metropolitan Planning Organization programs include travel demand modeling, transportation demand management, technical assistance, safe routes to schools, congestion management process, council of planning for US 1 Corridor, Metropolitan Planning Organization public participation & Title VI, mobility coordination committee, and the regional mobility management program.*

*The Board of Commissioners thanked the Capital Area Metropolitan Planning Organization team for the presentation and shared the importance of being a member of the organization.*

*Chair Dasher resumed the quasi-judicial public hearing requested by Southern Towers BTS, LP for a Special Use Permit for a new 285 ft wireless telecommunications tower on Parcel 60359, located at 4162 Bonlee Bennett Rd., being an area of .66 acres out of the 29-acre tract, Bear Creek Township that was started at the June 17, 2024 Board of Commissioners meeting.*

*Chair Dasher noted that the Board of Commissioners is required to act in a quasi-judicial capacity as it receives evidence and makes a decision. Dasher stated that this means that the applicant is entitled to a full evidentiary hearing. During this hearing the Board of Commissioners will receive legally acceptable evidence to establish sufficient facts to apply the ordinance.*

*Chair Dasher invited anyone that was going to speak on the item to stand for an oath. Dasher administered the following oath to those standing: Do you solemnly swear or affirm that the evidence or testimony you are about to provide is factual and truthful to the best of your knowledge. Those standing replied yes.*

*Zoning Administrator Angela Plummer stated that Planning Staff had no additional information since the June 17, 2024 presentation and the applicant is here along with some adjacent property owners.*

I spoke during the last session and brought my neighbors here so they can address you themselves.*

*Tracy Hanner - Adjacent Property Owner  
Thank you for allowing me to provide written comments prior to the July 15th meeting of the Board of Commissioners as it relates to the public hearing requested by Southern Towers BTS, LP for a special use permit for a nearby 285 foot wireless telecommunications tower on land parcel 60359, located at 4162 Bonlee Bennett Rd, in the Bear Creek Township. As I stated earlier in my email, my wife Gwendolyn and I are both cancer survivors of 6 and 16 years respectively. We attended the informal community meeting held on April 13, 2024, at the Harpers Crossroads Community Center hosted by southern Towers BTS, LP. We expressed our concerns at that time since the location of the Tower is just next door to our residential location. Although we are internet and cell phone technology starved in our area, we still have reservations about the location of the tower. As a resident of this community, I am writing to express my deep concern and strong opposition to the proposed installation of a cell phone tower near our home. Gwendolyn and I have personally battled cancer, I am particularly alarmed by the potential health risks that the proximity to such a tower may pose, especially being more vulnerable and susceptible to the potential adverse effects of electromagnetic radiation which could increase the risk of cancer recurrence. It took a while to do some research homework on the subject to educate myself and to be able to intelligently express our concerns which are stated below with references: 1. Health Concerns: Scientific Evidence: Several reputable studies have raised concerns about the potential health risks associated with long-term exposure to electromagnetic radiation from cell phone towers. For instance, the International Agency for Research on Cancer (IARC) has classified radio frequency electromagnetic*

fields as "possibly carcinogenic to humans" (Group 2B), indicating a potential link to cancer (IARC, 2011). Moreover, a study conducted in Belo Horizonte, Brazil, reported higher cancer mortality rates among individuals living close to cell phone towers (Dode et al., 2011). Vulnerability Due to Past Cancer: As a cancer survivor, my concern is compounded by the evidence suggesting that individuals with prior health conditions may be more susceptible to the potential adverse effects of electromagnetic radiation. Research indicates that cumulative exposure to such radiation could increase the risk of cancer recurrence or other health complications (Khurana et al., 2010).

2. Community Impact: Broader Health Risks: It is crucial to consider the broader community's health, including vulnerable populations such as children and the elderly. Studies have shown that younger individuals, who absorb more microwave radiation due to their physiology, are particularly at risk (Morgan et al., 2014). The long-term implications of chronic exposure in a residential area could be profound and far-reaching. Property Values and Aesthetic Concerns: Beyond health risks, the presence of a cell tower could detract from the aesthetic value of our neighborhood and potentially lower property values. We expressed our concern at the informal meeting about property value changes. This could have economic repercussions for all residents, not just those in immediate proximity.

3. Request for Reevaluation: Alternative Solutions: I urge the Board of Commissioners, relevant authorities and stakeholders to reconsider the proposed location of this tower. Alternative sites away from residential areas should be thoroughly explored to mitigate potential health risks and address community concerns. According to the supplementary documents submitted to the County of Chatham, site selection analysis was done by Airosmith Development for Southern Towers. Nine parcels in our area were analyzed and it appears only two were interested in having the tower located on their property. Most were not interested or did not respond. It's also stated in the search ring analysis that even this site selection does not guarantee to provide adequate service. Shouldn't it be a guarantee if you are risking the health of nearby citizens. Community Involvement: The decision-making process should actively involve community members, particularly those most affected and we appreciate the County notices, notifications of meeting date, and allowing the community to speak. However, Transparent discussions and considerations of scientific evidence and public health should guide the final decision. In light of these significant concerns, I respectfully request that the proposed cell phone tower installation be halted and re-evaluated with due regard to the health and well-being of the community. I would ask that the Chatham County Health Department authorities look into the health risk and provide further research assessment before the board makes their final decision. The person we see benefiting the most is the owner of the property who will receive a hefty compensation at our potential health risk expense.

Gwendolyn Fox Hanner - Adjacent Property Owner

My name is Gwendolyn Fox Hanner. I live at 4320 Bonlee Bennett Rd, Bear Creek NC 27207. I have been at this basic address for my entire life. My daddy bought this land from James Gilbert, who was a white man, during the era of Segregation and Jim Crow laws. He didn't seem to care that black people lived nearby. At this time people seemed to care about the land and other people. We never had any trouble in our neighborhood. Everyone seemed to get along. We knew each other's names. I think the new owner of this land may not have taken into consideration how we will be affected by the location of this cellphone tower in our residential area. My reason for speaking this evening is to let you know that I vehemently oppose the tower that has been planned for our area. I want you to take into consideration that both my husband and I and my cousin Barbara are cancer survivors. We really don't need something that will exacerbate our conditions and possibly cause new ones. I realize that we were told that there would be a minimal amount of EM radiation and that it would cause us no



*harm. Any amount of radiation exposure is harmful. I have several conditions that I am battling. All of which have to do with my immune system. I am sure I do not need any more radiation than I have already had. Knowing this about the radiation waves and our exposure to them and knowing that our property values will decline because of this tower, I urge you not to approve it. The person who will benefit monetarily by this tower lives a great distance away and will not be affected by the tower itself. I wonder if he would like a tower of this nature near his home. As I stated earlier, our health will be affected by this tower and our property values will decline. What will we have to leave to our children and grandchildren, but a cancer-ridden area with low property values? If you look around this room, you will notice four black people who will be greatly impacted by this, health and property wise. There are no white people in this same state here this evening. I don't want to make any accusations, but how does this look to you? How will it look to others? In conclusion, people of color have been and continue to be disenfranchised in this country, whether it be by healthcare or land ownership, jobs etc. Don't let Chatham County NC become the next to disenfranchise a group of people for the sake of the love of money.*

*Tami Lewallen, agent for the applicant Southern Towers BBTS, LP  
Stated that she was here to answer any questions.*

*Matthew Butcher, RF Engineer  
Shared a report showing no immediate health risks associated with the tower.*

*Richard Kirkland, Kirkland Appraisals, LLC  
Shared a report showing no adverse effect on property values due to a cell tower being in close proximity to residences.*

*Donnie Pell, owner of Southern Towers, Applicant  
Stated that he was here to answer any questions.*

*The Board of Commissioners asked a few questions regarding additional risks to those already sick, if any regulating entity was looked at adding more regulations regarding cell towers, and if there had ever been any adverse effects of property values related to a cell tower. The response and information provided showed the regulations in place are to protect all people to keep them safe from any known harmful effects from electromagnetic radiation, this includes children and highly populated, urban areas where cell towers may only be 500 ft away from each other. These regulations have been studied and supported by other entities such as the FCC, FDA, WHO, EPA, and OSHA to name a few.*

*Chair Dasher closed the public hearing, and the item was referred to the Planning Board.*

*Policy and Legislative Analyst Brenton Hart presented an update on the Digital Inclusion Plan and Grant Review.*

*Hart gave a broadband grant overview including maps of the unserved and underserved locations, locations served by fiber and cable.*

*Hart shared updates on the different grant programs including The Rural Digital Opportunity Fund, e Growing Rural Economies with Access to Technology (GREAT) Grant, and the Completing Access to Broadband (CAB) Program.*

*Hart shared an update on the Digital Inclusion Grant with Central Pines Regional Council which was received from North Carolina Department of Information Technology. The \$800,000 grant is to establish regional digital literacy efforts in Chatham and Durham Counties. The Grant will establish classes that will provide digital literacy training and a free laptop (post-training) for around 500 Chatham County residents and 500 Durham County residents, and allocate computer carts and laptops to use for digital literacy training in Wren Memorial and Goldston Public Libraries and*

*Siler City and Pittsboro Centers for Active Living.*

*Hart described the Digital Inclusion Plan and the steps taken to this point. Hart shared the availability, access, and adoption goals and strategies.*

*Hart stated once adopted, the plan will be reviewed by Chatham County annually for updating based on the following metrics:*

*Availability:*

- 1. The number of preexisting homes provided internet that year.*
- 2. Progress on Grant oriented project development within the year.*
- 3. Gross growth of networks within Chatham County.*
- 4. Annual surveys regarding student/resident internet availability.*

*Access:*

- 1. Change in the number of devices provided across the county.*
- 2. Usership of provided programs, and determination of communities most utilizing provided services.*
- 3. Change in surveys indicating students access to devices.*

- 1. Data on utilization of basic computing classes.*
- 2. Establishment and performance of programs that assist with adoption of broadband technologies.*
